

Trial of the King

Buzot demanded that a list of those who should vote, should be printed and sent to the Convention. This Motion was adopted, and it was likewise decreed, that all those Members who should not be present at the Appeal Nominal, should be censured.

They then proceeded to the first vote on the question, "Is Louis guilty of a conspiracy against liberty, and of attempts against the general safety?"

Several Members expressed themselves in the affirmative, upon grounds which had been assigned, others modified their opinion; the greater number observed, that they pronounced as Legislators, and not as Judges. — But there was not one voice which absolutely acquitted the Accused of the charges against him.

After the votes were taken, the President announced, that twenty-six Members had leave of absence; that five were absent from indisposition, and one it was not known from what circumstance; twenty-six had made different declarations; six hundred and ninety-three had voted in the affirmative. The President then pronounced the following

SENTENCE.

"I DECLARE, IN THE NAME OF THE CONVENTION, THAT LOUIS IS GUILTY OF A CONSPIRACY AGAINST THE LIBERTY OF THE NATION, AND OF ATTEMPTS AGAINST THE SAFETY OF STATE."

They then proceeded to the vote upon the second question: "Shall the Decree which the National Convention shall pass with respect to Louis Capet, be transmitted for the sanction of the people?"

Two hundred and eighty-five gave their voice for the sanction of the People, and four hundred and Eighty against it.

The Sitting did not rise till eleven at night.

LONDON, Jan. 10.

There are letters in town, which assert that sentence of DEATH was passed on the French King, on Wednesday last; so that it is probable that unfortunate Monster has before this time terminated his miseries.

It was yesterday (18th) rumoured that the French troops had been severely beaten in an action with the Prussians and Hessians, and that an attempt had been made to assassinate the King of Prussia.

The following letters from Frankfort, by this day's Mail, give the Prussian account of this business:

Frankfort, Jan. 6.

"Intelligence having arrived here, at one o'clock this morning, that the French were advancing towards Hochem, his Majesty the King of Prussia immediately set out, to put himself at the head of his troops. After that time we heard a very heavy cannonade, which continued till nine in the morning. We have just now learned, that the French have been driven from their posts with the loss of 700 men killed or wounded, and that the Prussians have taken from them 12 cannon, and 50 prisoners. At three in the afternoon, his Majesty the King of Prussia returned hither with the Duke of Brunswick."

Jan. 7.

"This afternoon 12 cannon taken from the enemy, and 160 prisoners, were brought to this city. The French were forced to retreat under the cannon of Cassel, and had only time to save themselves by retiring to their entrenchments. When the King arrived at Hochem, some French soldiers who had concealed themselves in the Church, fired from the steeple on his Majesty, but as soon as the Hessians perceived them they proceeded to the place, where they cut some of them to pieces, and threw the rest from the steeple."

On Sunday Lord Vis. Boyle was introduced at Levee by his father the Earl of Shannon. Lord Bunsicklen, on his way to the county Fermanagh, was robbed at Virginia of his pistols by a number of persons, who assured him of the most perfect safety in case he quietly gave up his fire-arms. His Lordship saw in their number a necessity for compliance: On receiving his pistols they made no further demand.

In the Dublin Gazette of Saturday last, a proclamation appeared from the Lord Lieutenant and Privy Council, for laying an embargo on the exportation of potatoes from this kingdom.

Yesterday morning at nine o'clock, the house of Mr. Pat. Byrne, Book-seller, in Grafton-street, suddenly fell; the family were fortunately apprised of their danger in time to escape. By this accident Mr. Byrne, (a much respected citizen) will sustain a very considerable loss, as his valuable stock of books, &c. lies buried in the ruins.

The bridge lately erected between the New Custom-house and Ballybough, by the Royal Canal Company, fell yesterday, and killed two of the labourers in the Canal.
