A PROCLAMATION.

BY THE RIGHT WORSHIPFUL
HENRY D'ESTERRE, Esq;
MAYOR OF THE CITY OF LIMERICK

WHEREAS it must appear a manifest deep concern to all well-inclined People throughout this City. It is therefore at this time highly incumbent on all Magistrates, to put in execution the Laws for the prevention of such, and particularly enforce an Act passed in the 29th year of the reign of the late King Charles the Second, intitled, An Act for the better preservation of the Lord's Day, called Sunday. Also an Act passed in the ninth year of the late King William the Third, intitled, An Act for the more effectual suppression of Blasphemy and Profaneness. And also an Act passed in the 1st year of his present Majesty, intitled, An Act for the better enforcement of the Laws for the prevention of the Day, called Sunday, and all other Laws now in force for the punishing of Vice and Immorality.

NOW I the Mayor of the City of Limerick, in my indispensable duty to exert the authority committed to me for the suppression of these increases do hereby give Notice, that all Persons who shall be found within my jurisdiction, playing at any games, selling of any flesh meat, fish, fowl, herbs, in stalls, standings or shambles, on the Day; and all persons exercising any trade or occupation carrying goods, during the time of divine service shall be punished with the utmost rigour of the Law. AND I do hereby require all Church-Wardens and petty Constables.
