

clothes and bedding are all saved, and having their pockets full of money, very little regulation can take place among them so long as it lasts.

In that part of Poland which has been seized by Russia, the Empress has issued orders that no communication shall be maintained with the Papal See, but only with the ecclesiastical authority at Petersburgh. Bishops are no longer to be appointed from Rome.

Considerable apprehensions are entertained least one or more of the Hamburg packets have been lost; and this in consequence of a report brought by a vessel said to be arrived at an Eastern port, which on the evening of Wednesday, when the wind blew so severely at S. W. saw another, of the description of a Hamburg packet, in the utmost distress. Several ships were driven from their anchors the same night on the above coast.

JAN. 5.—An order for fresh cured provisions for the use of the British garrisons abroad, the largest ever known on Government account, has been lately sent to Ireland. The quantity is 30,000 tons; of which 12,000 tons from Cork, 8000 from Waterford, and 10,000 from Dublin.

The Leeward Island Mail which arrived yesterday, has brought no intelligence of much importance with respect to the state of the Leeward Islands. (See London Gazette.)

No Mails from Hamburg have yet arrived.

### D U B L I N.—January 7.

We are much concerned to find, that in the County of Armagh, disturbances of the most alarming nature prevail;—Rioters, under the specious characters of Protestants and Roman Catholics meet each other, not like Men, but rather as ferocious Beasts of Prey—the consequence is, that the Peaceable of each Denomination are retiring from their Cabins and Farms.—Lord Gosford, as Governor of the County, called a meeting of the Magistrates on the 28th ult. at Armagh, and after delivering an Address in favor of the latter class, moved for and carried a Resolution, that a subscription be opened for the protecting their persons and property, and prosecuting offenders of every description in the County of Armagh.

We are sorry to find, that Caleb Barnes Harman, Esq; mentioned in the last page of this paper to have been wounded in an attack, by a party of Defenders, upon his house at Bawn, in the county of Longford, is since dead. He was brother to Lord Oxmantown, and Member of Parliament for the co. of Longford. The miscreants who perpetrated this atrocious act, have hitherto eluded the most vigilant search.

A Privy Council will be held at twelve o'clock this day, at the Castle, for the purpose, as we are informed, of taking into consideration the present high price of grain, and the exportation of biscuit from this city.
