A vessel has arrived from Baltimore in America in 27 days, having almost the whole time the wind at West and S. W. From a Baltimore paper of the 18th of December, we copy the following extract of a letter, dated Cape Francois, Nov. 2.

"The Venus is arrived here and announces two seventy fours and two frigates and 4000 men, to take possession of the Spanish part of St. Domingo, and we have cause to say, not a single Englishman shall be left on any part of the Island in six weeks."
