

Admiral Duncan's fleet arrived in Yarmouth Roads on Monday last, from a cruise off the Texel. Several of the ships have sustained much damage by the late heavy gales; but the crews are all in good health, and in the most perfect state of subordination. The Dutch fleet still remains in the Texel, and it is the opinion of Admiral Duncan that they are not at present in a condition to put to sea.—Admiral Duncan's fleet consists of the following ships: Nassau; Gan- ges; Director; Caesar; Venerable, Admiral Duncan; Ruffel; Belliqueux; Adamant; Lan- caster; Monarch, Vice-Admiral Onslow; Mon- mouth; Triumph; Agincourt; Veteran; Ar- dent; Lion: four ships are gone to the Nore to refit; Repeating Frigates, Circe and Champion.

The Lords of the Admiralty have re-commissioned the Montague, of 74 guns, which has been in dock for repairs at Portsmouth, and have appointed Captain John Knight to command her.

L'Intrepid privateer, of 20 guns, and 150 men, and the Chasseur ditto, of 12 guns and 50 men, were destroyed by the Brilliant frigate, between North Bergen and the Naze of Norway, on the 1st of September last.

The privateer la Mouche, belonging to Rochelle, has carried into that port an English prize, the cargo of which is estimated at 1,700,000 livres. This privateer has also captured two Portuguese vessels.

A determination evidently hostile to the trade of these kingdoms.

From the most minute investigation that has taken place, we can assure the Public, that there is no foundation whatever, for the report so in- dustriously propagated of the French General Clarke (brother-in-law to General Buonaparte) being in this City last week.
