He was cross-examined as to his having lent it to other persons, between his purchasing and giving it to his father; but this he denied. Thomas Kingsbury, Esq; recollected getting a paper from his son, containing the Letter of Marcus, which he read, and locked it up in his desk, until he returned it to his son. The paper was then read, and accurately compared by the traverser's Counsel with the record of the indictment. Mr. Walter Bourne proved the record of the conviction and judgment passed on Wm. Orr, of Farranishane, in the county of Antrim, for administering illegal oaths. An objection was made by Mr. Fletcher for the traverser, that it did not appear that the Peter Finerty now at the Bar was the person who had sworn the affidavit, or who lived in Church-lane, and published the *Prefs*. Major Henry Charles Sirr was then produced to prove, that upon his having gone to the office in Church-Lane, he met the Traverser, and having asked him was his name Peter Finerty, and was he the publisher of *The Prefs*, he acknowledged both circumstances. On his cross-examination, he said he did not ask whether the Traverser had published the particular Letter signed Marcus. He denied that he had ever followed the Carriers of *The Prefs* with a drawn sword, or that he knew of any Newspaper being in the pay of Government. An attempt then was made to draw from the Witnesses, upon his belief, an opinion that some Newspapers were in the pay of Government; but this kind of examination was objected to by the Attorney General, and over-ruled by the Court as perfectly immaterial to the issue. Major Sirr was then asked if he had ever been present when *The Prefs* Newspapers were seized? This, under the direction of the Attorney General, and the authority of the Court, he refused to answer. A long argument was then entered into by the Traverser's Counsel, that the question of identity was not sufficiently clear; but the Court declared its opinion, that there was evidence to go to the Jury. Mr. Fletcher, the Traverser's Counsel, then stated the case; which was, supposing the publication to be proved, which he did not admit, the right of the *Prefs* to comment on the conduct of Government. Barry Lord Yelverton proved that the affidavits shewn to him had been taken before himself; that he had tried William Orr at Carrickfergus; that he had transmitted the recommendation of the Jury in Orr's favour to the Lord Lieutenant, and that Orr had been three times respited. His Lordship was then asked a question to which the Counsel for the Crown objected. Lord Yelverton said, that sitting where he did as a witness, he could not think himself at liberty to answer without permission of the Court; that he had however no personal objection to any question whatever. The question which went to shew an impeachment of the credit of the witnesses against Orr, was over-ruled by the Court as not relating to the trial before them. It was insisted by the Traverser's Counsel that evidence tending to support the charges in the alleged libel was admissible, and that the Traverser could defend himself by proving the truth. This was over-ruled by the Court as for the law; the truth of a libel could not in a criminal case be offered to defend it. Counsellor Orr hoped to be determined of the

I have just heard a very unpleasant piece of news that I sincerely hope is not true, that the crew of the *Hermione* frigate have risen on the officers, put them all to death, and carried her into Cuba. She was commanded by Captain Pict, very fine fellow.—I have just heard the circumstance confirmed, as it was sent officially by the Spanish Governor at Cuba, to Sir Hyde Piker, who commands in this station. The Spanish Government have behaved in this business with real honour; as they have put all the crew in irons, and sent home to Spain to know what they are to do with the ship and men. So I trust they will receive the punishment they deserve.
