Trim, March 12. Peter Finegan, Pat. Hall, and John Fallon, were indicted, for that they on the 6th of November, 1798, broke and entered the dwelling-house of John Dixon, and feloniously took thereout one gun and t bayonet.

John Dixon and Richard Dixon, fons of John Dixon the elder, and owner of the house, positively swore to the sact and to the persons of the prisoners; but several witnesses proved an alibi on the part of each prisoner, and they were all acquitted.

John Kenney, was indicted for that he with others, on the 12th of September, 1798, did burglariously break and enter the dwelling house of Richard Langan, and feloniously take bank notes to the amount of three guineas, and one gun and one blunderbuss. Richard Langan the profecutor fwore, that on the 12th of Sept. laft, between 7 and 8 o'clock in the evening, his house was attacked by leven armed men, five of whom entered the house, and forcibly carried away the property mentioned in the indictment, and was politive that the prisoner Kenney was one of the party. Upon his cross-examination, he faid, he did not believe that the prisoner was forced there against his will, for he had a pistol in his hand, and was the first who demanded the money .-Verdict, Guilty.

Wednesday, March 13.

Peter Fox, a most nororious offender, known by the title of Captain Fox, was capitally con-

victed by the clearest evidence.

William Goldrick was put to the bar and arraigned upon five several indictments for burglaries and robberies. He moved to put off his trial upon an affidavit, stating that Capt. Black, of the Duke of York's Fencibles, was a material

witness, and was now in England.

The Counfel for the Crown warmly opposed the motion, representing the prisoner as a most langerous offender, who had been convicted about a year ago of robbery, before the late Prime serjeant, senienced to death, but from the misaken humanity of Government, had received a ree pardon, was turned loofe upon the public, ind in the course of one month, (January last) and committed a number of atrocious offences. was also proposed to examine the gaoler, to new that this prisoner had repeatedly attempted break gaol, and had declared he would put hanged on Saturday the 23d init,-Dan. Fogarty, and Mich. Purcell, for a burglary and felony, to be hanged on Tuefday the 2d of April next. - John Gain, John M'Carthy, Mich. Cooke and Wm. Smithwick, convicted of the like offence -Gain and M'Carthy to be hanged on the 2d of April-Cooke and Smithwick to be hanged on the 25th of May next .- Several others were lentenced to be transported, &c.

Yesterday, the Right Hon. Lord Chief Baron Yelverton, and the Hon. Justice Chamberlain, Judges of Affize for the Leinster Circuit, fet out

from hence for Kilkenny.
