Arthroath April 30 .- On Wednesday the 22d instant a very uncommon phenomenon was observed here between the hours of two and four P. M. A bright halo appeared round the sun of a very uncommon magnitude, diametre being 54 degrees; also a large luminous circle parralel to the horizen, diameter about 93 deg. its altitude equal to that of the sun. Its centre nearly in the zenith of Artbroath. The periphery of this circle passed directly through the centre of the sun; on the eastern part of this circle two beautiful parhelia were distinctly visible, as also two much more resplendent on the western part.

Extract of a Letter from a Gentleman in Plymouth to his Friend in this City, dated May 15, 1806:

" SIR,

"This morning the Active frigate arrived here with Sir H. Popham's first Lieutenant, whom he took out of a transport off Cape Finisterre, homeward bound.—He is gone express to the Admiralty with the news of one of the frigates under the command of Jerome Bonaparte, being taken at the Cape of Good Hope, he sent the frigate in, which came to anchor close by the Diomede of 50 guns; all our fleet had Dutch colours flying, he says they are gone to India. The Powerful, that Sir J. T. Duckworth sent to India, has past the Cape some time before them .-Admiral Duckworth arrived here yesterday morning in the Superb."

On the 13th inst. Mr. Corry, presented to the House of Commons, two Petitions against the Limerick Taxation Bill; the one from the inhabitants of Newtown-Pery and Clare-street, and the other from the inhabitants of St. Francis's-Abbey, when both, were ordered to be taken into consideration on the second reading of the

Two members of that Corps immediately took a post-chaise and hastened to the scene where so many robberies had been committed.

They had scarcely got up to the place, which goes by the name of Murdering Bridge, when a fellow, armed with a musket and pistols, fell exactly into the trap which was laid for him. He came forth, as usual, from his lurking place, made the Driver stop, and ordered the Yeomen to deliver their money, on pain of the usual forfeiture. Though their intention was merely to secure kim, yet, as their own lives were now attacked, one of them shot him dead on the spot. The gold watch was found on him which he had taken that very morning.—From various circumstances it would appear, that this was the principal, if not the sole actor in these depredations; and the traveller, at least, will feel much obliged to the Fermoy Yeomanry, for ridding them of so troublesome a visitant, by a species of stratagem as ingenious in the plan, as cool and spirited in the execution.
