CAPE OF GOOD HOPE.

The letter of our Correspondent at this settlement has but just reached us; it came by the William transport, which has brought home the detachment of the Queen's, or 2d Foot, which, with the flank companies of the 54th, it will be recollected, were taken on their passage from Gibraltar, and carried to the Cape, while in possession of the enemy.

Our letter is dated November 11, at which time, neither the supercession of Sir David Baird, nor our misfortunes at Buenos Ayres, were known at the Cape.

The troops at the Cape were in high health, and in the very highest state of discipline. Sir David was indefatigable himself, and in the sun all day.

The whole army was to be encamped at Newlands on the 15th November.

In the William, several Dutch families have come home, and a few invalids from the Regiments at the Cape, with the following Officers:

Captain Collins, of the 72d Regiment.

Paymaster Malcomson, of the 93d ditto.

Riding Master Humphries, of the 21st Light Dragoons.

Brigadier General Broderick and Ackland, and Colonel Banbury have returned from the army in the Mediterranean. Our military readers, and the country in General, will rejoice to hear that Sir John Stewart, Sir John Moore, and Sir Sidney Smith remain for the present with the Army—such heroes we would regret to see unemployed at the present moment. It is said that General Fox will return to England at no very distant period; we have even heard the names of two distinguished Officers as his successor in the chief command in the Mediterranean.

Much apprehension is entertained at Sheerness for the safety of the Swift sloop of war, James Wright Captain: she sailed from the Nore for Elsinour on the 22d November, (without any ship under convoy), and has not since been heard of; the opinion of her having foundered at sea is unhappily much strengthened, by one of our cruizers having fallen in with part of the wreck of an armed ship near Heligoland.

Mr. Merry, our late Ambassador to America, arrived at Liverpool last week in the ship Leonidas, Capt. McKenzie, and set out from thence for London on Friday.

FIRE.—On Tuesday afternoon, what is called the Rocket House, in Woolwich Warren, was discovered to be on fire, the gates of the arsenal were instantly closed, and by the exertions of the artificers and labourers inside, the conflagration was extinguished without doing any material damage.

MURDERS.

On Tuesday evening James Sherring was charged on suspicion of the wilful murder of Timothy Mechin, at Tomin, in the county of Limerick, in the month of December, 1805.

William Kelly, of George yard, St. Giles's, said that he had known the prisoner from his infancy; that he saw him at Tomin Fair in December, 1805, at which time a very great riot took place, and Timothy Mechin was murdered. The witness had been informed that the prisoner had been concerned in the murder. He assisted the deceased after he was wounded, and discovered that he had been severely cut with a sword.—He died the following morning.

The deceased told him that the prisoner and five others had been concerned in wounding him; one of the name of Kenan had been executed for the offence, having been convicted at the Assizes for the county of Limerick. At the time the deceased told him of the persons who had wounded him, he was sensible he was dying, and desired him to bring a clergyman to him, as he was sure he could not live longer than the next morning.

John Gorman, alias Connor, was charged yesterday with being concerned in the same murder.

Wm. Kelly said, he knew the prisoner very well in Ireland; he went by the name of Buck Gorman, and is one of the men whom Mechin described when he was dying to have been concerned in murdering him at Tomin Fair; that he knew the prisoner had been indicted for the offence, but had fled from Ireland after the execution of Kenan.

Mary Bentley was charged with being concerned with Elizabeth Godfrey in the wilful murder of Richard Prince.

It appeared from the evidence of the widow of the deceased, that on Christmas Eve a quarrel arose in the apartments of these women, where a man was accusing them of having robbed him; the watch was called, and the girls were taken to the watch-house, but discharged next day, as the complainant did not attend. These women then went to the apartment of the deceased, loaded him with abuse for his conduct; and Elizabeth Godfrey ran a knife into his cheek, near his eye—of this wound he died in a few days. They were committed for re-examination.

Wm. Wainwright and John Matthews, two youths about sixteen years of age, were charged with cutting a square of glass out of the shop window of Mr. Warne, hosier, in the Strand about five o'clock on Monday afternoon, and stealing a quantity of stockings and other articles. The charge being clearly proved by several persons who watched them, they were committed for trial.

Accident at Covent Garden Theatre.

Tuesday a young man named Davis, of a very humble description, was brought before Mr. Justice Reed, and the other Sitting Magistrates, charged with maliciously throwing a glass bottle from the two shilling gallery of Covent Garden Theatre into the pit, on the preceding night, and dangerously wounding Mr. James Shephard, a gentleman resident in Millbank-street, Westminster.
