the English ships at that place having been order-
 ed to quit Memel within a certain time. Several
 vessels in consequence sailed immediately without
 waiting for their cargoes. Others, which left
 Memel afterwards, have brought intelligence that
 the precaution of sending the ships away had been
 taken immediately upon intelligence having been
 received of the conclusion of the treaties of peace
 between Russia and France, and Prussia and
 France, which it was feared contained stipulations
 for detaining British ships.

The Mary is arrived at Grangemouth, from
 Memel, whence she sailed on the 16th ult. two
 days later than any other ship in the fleet, at which
 time no steps had been taken hostile to the Bri-
 tish interest. Lord Hutchinson had returned to
 Memel, in the Astrea frigate, two days before
 Captain McLeod left it.

The Hamburgh Correspondent of the 29th
 ult. states, that dispatches inviting England to ne-
 gotiate for peace, were forwarded from Tounin-
 gen on the 27th.

A Convention has been concluded between the
 French and Prussians, relative to the contributi-
 ons levied in the Prussian territories, and the pe-
 riods at which the French troops shall evacuate
 those territories.

Bonaparte left Konigsberg on the 13th, and
 on the 17th arrived at Dresden, where he remain-
 ed till the 22d, when he set out for Paris.

Extract of a private letter from Altona, dated
 July 31.—“We have this day received the im-
 portant intelligence from Schwerin, of the date of
 the 27th inst. that the Count of Mecklenburg has
 received advice by a courier, that the French
 General Molitor was at that time in Salsund,
 treating for the surrender of that fortress to the
 French troops. Flags of truce were continually
 passing and repassing, and every hour the result
 of important negotiation is expected to transpire.
 The King of Sweden is reported to have embar-
 ked for Malmoe.”

Copenhagen, July 28.—It is reported here that
 the English will place all the ports of the Baltic
 under a strict blockade.

The last accounts from the Duchies mention
 nothing of the return of our troops collected
 there, but rather render it probable that no change
 will take place there, in this respect, before the
 beginning of the winter.

The Master of a vessel arrived in the Sound,
 from the Baltic, while off Boraholm, heard a very
 heavy cannonade, which appeared to proceed from
 the coast of Swedish Pomerania.—*Hamburgh Cor-
 respondent, August 1.*

Warsaw, July 22.—The General Directory has
 just issued the following Proclamation:—

“Citizens,
 “You have done every thing which the love of
 your country, your honour, and the example
 your ancestors required of you. You have over-
 come all difficulties; you have not hesitated to
 sacrifice your lives, your fortunes, and the most
 sacred ties of nature, for the happiness of your
 country, and to again obtain the name of Poles.
 A single word from his Majesty the Emperor of
 the French has armed you all. His vast genius
 insures you victory. By your firmness, all your
 enterprises will be crowned with success. Despire
 all the false reports which the inveterate enemies
 of your country circulate. The greatness of soul
 of Napoleon is your *Aegis*.—Our fate cannot be
 determined at this moment; an impenetrable veil
 must conceal it for some time from our eyes. Let
 us adore the sublime wisdom of him who com-
 mands half the world. Banish the despair of your
 hearts. Be penetrated with obedience, and re-
 sign yourselves to the confidence you ought to
 have in his goodness, your happiness depends on
 it. The least murmur, the least opposition to his
 will, may destroy all that you have hitherto done.

ticular name, addressed a letter, dated the 22d
 of July, to Lord Castlereagh, in which he has had
 the audacious falsehood to state that a meeting of
 disaffected persons had been held in this city.—
 The authority we have for this letter being writ-
 ten, is an acknowledgment from one of the Mi-
 nisters of the receipt of it, as well as its tenor
 and purport, which acknowledgment we now have
 before us. Now, with respect to the fact of any
 such meeting having taken place, no assertion on
 earth could have been more false than that con-
 tained in the letter which the Minister acknow-
 ledges to have received: and with respect to the
 writer, we have been assisted in close enquiries to
 discover him, and we cannot find any person an-
 swering to the name which he has made use of, in
 this city, except a poor man, a weigh-house por-
 ter, who it is morally impossible could have writ-
 ten it; and the letter, directed from an official
 quarter, according to the signature used by the
 supposed informer, for want of such real person
 being to be found, has fallen into other hands.—
 The name is therefore assumed to cover the com-
 munication of a gross falsehood from being traced
 to the author; and as to the motives of such a
 fabrication, they can only be ascribed to depravity
 of the worst stamp in the Citizen of any county,
 or the subject of any King.—*Cork M. Chron.*

Tuesday night, at 11 o'clock, departed this life,
 in the 85th year of his age, at his house on Mer-
 chants' quay, the venerable and highly respected
 Sylvester O'Halloran, Esq. an eminent Surgeon
 and Manmidwife, as well as a celebrated Histo-
 rian, M. R. I. A. and of most of the Literary and
 Honorable Societies in the United Kingdom; he
 studied Physic and Surgery in Paris and London,
 and made a rapid progress in his studies, as he
 published the first of his works, before he was 21
 years of age;—he afterwards wrote different trea-
 tises, Medical and Political,—a General History
 of Ireland, down to the close of the 12th century
 —and in 1803, he published a second Edition
 thereof, greatly improved; he was highly learned
 in the Irish Language and ancient Laws, and was
 ever remarkable for his loyalty and attachment to
 the House of Brunswick, a steady supporter of
 its Constitution, and a warm advocate for the ho-
 nor and interests of his native Country;—his re-
 mains will be interred in his family vault on
 Saturday next, at Killilee.

The Royal Assent has been given, by commis-
 sion, to the following bills:—

A Bill to allow certain drawbacks on the ex-
 portation of goods, wares, and merchandize, into
 and from Ireland.—An Act relating to Stamp Du-
 ties in Ireland.—An Act for building glebe-houses
 in Ireland.—An Act for regulating and securing
 the collection of the Duties on Spirits in Ireland.
 —An Act for securing the collection of Gold and
 Silver Plate wrought in Ireland.—An Act to regu-
 late the trade of rectifying Spirits.—The Irish An-
 nuity Bill.—An Act for the Improvement of the
 Fisheries on the coast of Ireland.—An Act for
 defraying the charge of the pay and clothing of
 the Militia in Ireland; for holding Courts Martial
 on Serjeant Majors, Serjeants, Corporals and
 Drummers, for offences committed during the time
 such Militia shall be embodied; and for making
 allowances in certain cases to subaltern Officers of
 the said Militia during peace.
