Another letter, same date, says, "That 17000 men landed on Zealand, under the command of General Lord Cathcart. Since the disembarkation, our troops have had several partial affairs with the Danes, who have lost 300 men and some cannon.

"Many of the inhabitants have, owing to a scarcity of provisions, applied for permission to leave Copenhagen, which was refused."

Extract of a letter from Captain Lowes, of the Catherine and Eliza, bound to Petersburg, dated, Gottenburgh, August 24.

"On the 20th inst. we were boarded near the Koll, by his Majesty's cutter, Sylvia, Lieut. Drury, who informed us that hostilities had commenced with the Danes, and that we could not proceed with safety to the Sound. However, I pushed on in company with six sail; they being light ships, got a-head of us a few miles, when I perceived a large ship among them, which proved to be a Danish frigate. Immediately after, I saw bearing down, fortunately, the Astrea frigate, Capt. Munbar; an action commenced, which lasted 20 minutes, when the Dane struck, and the ships captured by her of course liberated. I expected every moment to have been taken, and certainly should had not the frigate come up: I was ordered home and shall proceed. There are about 20 sail put in here, bound to Riga and Petersburg, but will proceed home to England."

DUBLIN—SATURDAY, SEPTEMBER 12.

On Thursday last, the Strabane Supplementary Yeomanry, commanded by Captain Smith, went through a variety of military evolutions, highly satisfactory to their officers and equally honourable to themselves; after which they proceeded to fire at a target placed at the usual distance. After passing an evening (entertained by Lieut. Fleming, one of their officers) in the most perfect harmony, Protestant, Catholic, and Presbyterian, uniting in that one great chain of human happiness, loyalty, friendship, and brotherly love, they retired at an early hour to their respective homes, highly pleased with the duties, and pleasures of the day.

On Thursday last, John Milligan of Strabane, labourer, was committed to Omagh gaol for three months, by the Rev. Stewart Hamilton, Provost, and Robert Cochrane, Esq. two of his Majesty's Justices of the Peace, for interfering with the labourers, and for his soliciting and encouraging them to stand out for an advance of wages, contrary to the Statute in that case made and provided.

As the time may not be far distant when Portugal will be compelled to employ her navy against us, the following list of it may not, perhaps, be unacceptable. Several of them, in their present state, are totally unfit for service.

13 Ships of the Line,	74 and 80 guns.
14 Frigates,	36 and 44 do.
10 Brigs,	14 and 20 do.
2 Schooners,	12 and 16 do.

Some of those vessels are very handsome, and equal, if not superior, to any in the British navy, according to the opinion of Lord St. Vincent, who inspected several of them when at Lisbon.—The timber is all got from the Brazils, and is more like iron than wood, but withstanding the excellence of their ships, the Portuguese sailors who man them are but indifferent, whilst the Portuguese who are in the British navy are esteemed to be good sailors.

We learn from very respectable authority, that government, after some previous arrangements, have finally determined that a mail coach should run every day from Cork to this town, thro' Macromp, Millstreet, and Killarney, in 14 hours. The very extensive commercial, as well as incidental intercourse, which subsists between this county (particularly this town), and Cork, has this long time back imperatively claimed the interference of such an auxiliary, and we hesitate not to say, future experience will confirm the advantages which may be expected from such a beneficial establishment.
