The learned Judge gave a concise charge, recognizing an unquestionable point of law, and deducing an inference from the defendant's letter of vindication, that he proved himself the dupe who laid himself open to this action, while other paramours more cautious perceived the snare that was laid for them.

The Jury found a verdict for the defendant with costs.

Clonmel, Dec. 10 .- On Sunday last a serjeant's party of the dragoons from this town, having arrived, by appointment, at the Finger Post on the Clogheen road, at the turn towards Knocklofty and Newcastle Bridge, between nine and ten at night, they were met by the Earl of Donoughmore on horse-back, who conducted them through the town of Ardinan, by Carrighatagha, and Ballybrado, to the neighbourhood of Ballylooby, where a large body of miscreants had assembled in arms some time since, and by whom the house of Mr. William Lane and other houses had been plundered of arms, and other outrages committed. Some houses were searched for two of the persons against whom his lordship had received information upon oath as ringleaders in these disgraceful proceedings; but neither of these ruffians was found at home, and it is more than probable that they were both at the very moment employed, in company with others of their associates, in breaking into the house of Mr. J. Miles, in the neighbourhood of Ardfinan, in search of arms; such outrage having been committed on that night by four men, two of them armed with blunderbusses, at the very time when the dragoons were upon their march between Ardfinan and Ballylooby. His lordship and the party returned by the way of Cahir-the dragoons did not reach their barrack till Monday morning, at four o'clock.
