

The last London Gazette from his Royal Highness the Prince Regent, for a General Fast to be observed throughout England, Ireland and Scotland, on Wednesday the 20th of March.

We Freeman's Journal give insertion to the following article, for which there appears to be some authority:

It is very confidently stated, that some circumstances which have tended to produce in an exalted quarter a determination not, at present, to make a change of Ministry—will lead, at no distant day, to the formation of a new administration, composed chiefly of the particular friends of an illustrious personage.—It did not escape the sagacity of that personage, that a strict adherence to the arrangement of 1806, as proposed, would leave his friends little more power than the two noble lords, who were to fill the offices of first Lord of the Treasury and Foreign Secretary, choose to dole out to them—in the event of a Ministry, formed of those who more particularly possess the confidence of his Royal Highness, Lord Holland will be the premier, and in the Cabinet there will be Lord Lauderdale, Mr. Ponsonby, Tierney, Lord Moira, Lord Erskine, Lord St. Vincent, the Dukes of Norfolk and Bedford, the Marquis of Lansdowne, and Mr. Sheridan.

On Thursday there was a meeting of the Common Council of London, for the purpose of presenting an address to the Prince Regent. The address was proposed by Alderman Wood, and seconded by Mr. Waithman; when after some discussion, it was carried by a majority of voices without a division. In substance it conveys with his Royal Highness on the afflicting illness of his Royal Father; laments the restrictions which have been imposed on the royal functions in the hands of the Regent; but expresses an ardent hope, that the powers which he still enjoys will be employed in the reform of abuses, and in promoting the best interests of the country.—The court then adjourned.

Yesterday se'night, a motion was made in the court of King's Bench, by Mr. O'Connell, for a criminal information against the Officer who had ordered the Catholic Soldier, Spence (about whom so much has been said) to be punished. The Court refused the motion for the conditional order.
