A considerable number of transports have arrived at Portsmouth from Lisbon, after a passage of three weeks—and brought home the skeleton regiments of the 2d battalion 7th Fusiliers, 2d, 48th, and 7th King's German Legion, which have respectively borne a part in the capture of Oporto, the battles of Talavera, Busaca, Fuentes d'Onor, and Albuera. Owing to the losses they have sustained in these and other operations during the campaign, and the usual casualties of the climate, they were ordered to deliver up the remainder of their men (about 250 or 300 of each battalion) to their several 1st battalions—the officers and non-commissioned officers only returning home. The transports also brought 300 wounded officers and men: among the former were Major Grant and Captain C. Wemyss, 7th regiment; Captain Maxwell, 22d; — Stevens, 3d Buffs; — Gail, 28th; and — Ferns, 65th; besides several subalterns, all severely wounded in the battle of Albuera, and the attack of Badajoz: Lord Aylmer, Assistant Adjutant General; Colonel Blunden, dragoons; Major Lloyd, 24th and Captain Fenwick, guards, were among the passengers.
Two transports arrived on Thursday at the Pidgeon House, Dublin, bringing part of the Anglesea and Leicestershire militia regiments.

CORK ASSIZES.

The following are the convictions in the city court:
Edmond Laffan, indicted for street robbery, found guilty of stealing, to be transported for seven years.
— Laahy and — Neal indicted in one count for stealing notes to the value of 20 guineas, from Patrick Hickey, and in another for swindling him of the notes, under the pretence of their having the power of changing silver into gold, and promising to give him 100 golden guineas of their manufacture, for £20 in notes; having thrown a tenpenny bit into a small bowl containing some liquid, and pretending that a guinea which they produced, was the identical piece which they had thrown into the bowl, but which was changed by their power into gold.—Verdict not guilty of the stealing, but guilty of the swindling.—Sentence, to be fined each £10 to go to the Exchequer, to be confined a fortnight, and give security for seven years themselves in £50 each, and two sureties in £25 each; and as the Judge looked upon the prosecution in some degree culpable, he did not insist on restitution to him.
Frederic Mee, indicted for bigamy. It appearing that he and the wife being protestants, were married by a Roman catholic priest, the marriage was of course null in the law and he was acquitted. The Judge regretted that the case of criminal prosecution was not excepted in the act, and after a severe reprimand for his disgraceful conduct, ordered to be discharged.
John Mahony, for stealing three banker's notes, value £24, 1s. 10d. the property of — Buckley. Guilty.—Transportation for seven years.
John Lyons, for the murder of — — no prosecution, which could attach any suspicion to the prisoner, it rather appeared, that in drunkenness, the deceased received some injury by falling, in consequence of which an extravasation of blood took place on the brain, which caused his death.
Cornelius Mahony, a noted offender, for stealing money and other articles to the value of £20.
Ellenor Holland, for stealing 15 guineas in gold, &c. from a soldier—she was sentenced to be transported, unless before the time of sending her to Botany Bay, a house of correction should be established.
We are authorised to state, that the sundry allegations lately set forth against Mr James O'Neill, of Waterford, by one of the assignees have been fully explained to the satisfaction of the commissioners and other creditors, at his several examinations—and that had an investigation of those charges been gone into at a late trial, (which was the express desire and wish of the bankrupt) his honesty and integrity would have been clearly apparent. A reference to his schedule would alone prove the cruelty of such accusations, he having therein accounted for about £17,000 more than he is indebted to the world, being his gain during eight years and a half; the items of which were, after mature consideration, allowed under the commission, being considered just; and although his assignee has thought proper to state to the contrary, particulars of every entry or transaction with his brother in London had been duly furnished him, as well as his several accounts current. The flax which he also alludes to, as not entered, had been duly charged to Woods on his books, on the amount received by his said assignee, months before he chose to bring forward his prosecution against the unfortunate bankrupt.—*Dublin Corres-*

Sir Samuel Hood proceeds immediately to India, in the Swiftsure, 74 guns, Captain Wesley from Portsmouth.
The Prince Regent has been pleased to direct, by an order in council, that Lord Wm. Fitzroy, who had been dismissed from the command of the Macedonia, at Lisbon, and struck off the list of the royal navy by sentence of a court martial, shall be restored to his former rank of Post-Captain.
Within the last 10 days, an alteration has been observed by our cruizers to have taken place among the enemy's ships in the Scheldt. It is ascertained that 12 sail of vessels, including two-deckers, sloops, barks, &c. have proceeded up that river from the situation in which they had previously been discovered. Whether this movement has taken place for the purpose of inducing our ships to relax in their vigilance, is not known. A three-decker which has been some time building at Antwerp is now completed, and will speedily be launched.
