tle-Guilty. Extract of a letter from Chester, May 30.

"I have just returned from the court house, where I heard sentence of death passed on either fifteen or sixteen of the unfortunate rioters, and about the same number doomed to transportation and imprisonment. From what the judge said in passing the awful sentence I presume that mercy will be extended to many of the transgressors. The General Ludd that was tried and ordered to be transported, is a most ridiculous drunken looking old man, and was happy to see such a contemptible being pointed out as a leader; for such an object, I am persuaded that there is not a treasonable plot (at least) at present of any serious description ;yet it appears, that the swearing system has got to great lengths. I am very much inclined to think that the lower order of the people were not heretofore aware of the dangerous consequences their lawless conduct was liable to. I thus give you the earliest intelligence of the result of the special commission in this court."

Accounts from Newcastle state that tumuit and disorder yet prevailed in Cumberland. On the night of 15th inst. the corn mill at Monkhill, near Carlisle, was broken into by a number of persons, whence not less than 150 stone of oatmeal, and 65 stone of flour, were carried away or wasted. On the 16th, about twelve at night, George Johnson and Margaret Barnes, both of Burgh, were attacked near Coalfelihill by two men; but footsteps being heard, they thought it prudent to retreat. The persons who came up were C. Robinson, of Drumburgh, and J. Robinson, of Glasson, two industrious men, who had been at Carlisle receiving payment for some work done, and who accompanied the two first mentioned persons. They had not proceeded above half a mile when they were again assailed by a banditti, consisting of seven, who presented their pistols, and, after having much injured the travellers with bludgeons and stones, compelled them to deliver their property.

The report which has been circulated respecting the death of Mr. Perceval having been known at a village near Annan, 24 hours previous to the unfortunate event, we have authority to say is founded upon misapprehension. An official inquiry has taken place, and though not finished, there are sufficient grounds to conclude that the report originated from the murder of one of the manufacturers in England in the late disgraceful riots .- Dumfries Journal.
