Knocklofty, May 3, 1816.

Most Rev. Sir-I shall have the greatest pleasure in presenting to that House of Parliament, of which I am a member, the petition of the Roman Catholic Bishops of Ireland, which I have had the honor of receiving, accompanied by your. acceptable letter of the 29th ult. and shall not fail to enforce your objects and theirs, with that zeal which repeals unjustifiable suspicions and belongs to the support of the legitimate cause.

Calling to my mind, with grateful recollection, those resolutions of the 23d and 24th of August last, by which your brother prelates and you unanimously pledged yourselves "to an unequivocal opposition to the handing over to the crown, of any power to interfere, directly, or indirectly, in the appointment of Bishops for the Irish Roman Catholic church," I was not unprepared for the renewal of the same declaration -of the same solemn pledge on your part, in the petition which you have now done me the honor to desire that I should present to parliament.

For myself, who have on all occasions so explicitly avowed, and so recently too, in my late communication with a very dignified member of your cenerable body, my sentiments upon the subject of domestic nomination, that valuable substitute which you suggest to parliament in lieu of those concessions against which you have protested. It is surely quite homecessa: y to express my entire concurrence in that just and liberal policy, which, in restoring to the second order of the sathol c clergy the exercise of their too long suspended rights, would go a greater length, I conscientiously believe, towards the assurance of the proper relations to each other, in the peace and harmony of all the classes of your own communion, and towards the consolidation of the protestant stare, than any other expedient within the reach of political wisdom to devise -- if, indeed, it would not appear to be the habit and extent of modern information either to probe the bleeding wounds of my unfortunate country to the quick, and to leave them unbound, rankling in the public view, than to endeavour to sooth, by kind and lenient treatment, the unhappy victim of a perverted system and inveterate neglect, and to administer to him, in any one solitary instance, the healing balm of conestiation and mercy.
