It is, however, hoped, that the Public will insure the success of this benevolent undertaking, by Subscribing each according to his means, for who would deny the small pittance of a Pound, to promote the well being of Society and the happiness and comforts of the Poor, instead of throwing back upon the World, and into all the deplorable misfortunes of ignorance and vice, a regular succession of One Thousand Poor Boys, who in this House of Mercy, will be always trained up in the happy baths of Sobriety, Industry, and Virtue-thus securing their happiness both for this and the next life, since according to the Holy Scriptures, " Train up the Child in the way he should go, and when he is old he will not depart from it."
