 Eye, in Suffolk, aged 80 years, the Rev. Robert Mays.  
 He was Captain on board the Princess Frederick man of  
 war, at the taking of Louisburgh, and was present at the  
 death of General Wolfe, and the taking of Quebec, in 1759.  
 For the last thirty-nine years, this venerable Clergyman has  
 been Rector of Kirton, in that county—At Greenhook,  
 Hampshire, Vice-Admiral Edward Oliver Osborn—John  
 Aiken, Esq. of Pettigo, a Magistrate for the Counties of  
 Fermanagh and Down, and formerly High Sheriff of the  
 Co. Fermanagh—At Chester, John Manwaring Uniacke,  
 Esq.—At Castle-Treasure, Co. Cork, Chris. Bond, Esq.—  
 Last night, at his Lodgings in Mary-street, Mr. Richard  
 Prendergast; for many years he practised in the Manor  
 Court of Adare, as a Solicitor—Yesterday, in Frederick-  
 street, Mr. John Hilliard, accountant—In Edinburgh, Pro-  
 fessor Christian—At her son-in-law's, at the Wood, Mrs.  
 Byves, relict of the late Edward Byves, Esq. of this City;  
 a Lady whose death is a source of great affliction to her  
 highly respectable family and friends.—This morning, at her  
 Brother-in-law's, (Thomas Gielston, Esq.) in Newcham-  
 street, Mary, third daughter of the late Ringrose Atkins, Esq.  
 of Prosper, in the County of Cork. This innocent young  
 Lady, bore a lingering illness with a resignation which  
 marked the character of a Christian—not with cold apathy,  
 but rejoicing in hope of the Glory of God, assuredly trusting  
 in a promise which can never fail, "all things shall work  
 together for good to them who are the called according to  
 his purpose"—she, indeed, experienced the fulfilment of this  
 gracious promise, for amidst bodily anguish, her spirit  
 rejoiced, and her constant prayer was "not my will but  
 thine be done, O Lord."
