We were nearly five months on ship-board, during which time many quarrels took place, and the people on ship's crew robbed the trunks and boxes: my box was opened and robbed of many things. Our leader never troubled himself about it, or any thing; and the result was that many respectable families left us the moment we landed. On the 17th March, when we got into Table bay, none of us was suffered to land, except our leader, Mr. Baillie, who gave us all an infamous character; and we were immediately ordered away to Algoa bay, and there landed, and sent 150 miles in waggons to the banks of the Great Fish River, where, after measuring one acre of land for each person to build his house on, they shut us down like dogs in cages. The horror I there felt I cannot describe—I felt for thirty years without leaving; and for what? a few acres of stony soil.

The general rates were—New Red Wheat, 22s. to 28s.; Old ditto, 25s. to 27s.; New White, 26s to 28s; Oats, new, 10s to 14s 6d; Old, 14s. to 16d. per barrel; Barley, 13s; Bere, 11s 6d. to 12s 6d; Rape-seed, 34s to 36s; Oatmeal, 12s to 15s; Flour, 18s. to 20s. prime Seconds.

London Corn Exchange, September 11.

Wheat but a short supply of Wheat this morning from Essex, Kent, and Suffolk, and the greater part being new, and ordinary quality, was dull of sale, at a reduction of full 1 per quarter; but prime and picked samples of old obtained last Monday's prices. The arrivals of Oats during the week being immense, the trade was very heavy at a decline full 2s. per quarter. In Barley, Peas, and Beans, there little or no alteration.

Ports of Great Britain continue closed against the admission of all kinds of Foreign Grain, Pulse, and Flour. From the British Colonies, Oats and Pease only are now admissible for home consumption.

The following Resolutions, proposed by Counsellor Howly, and seconded by Thomas Roche, Esq. were unanimously adopted:—
Resolved—That we are determined to persevere in opposing that system of usurpation which has for years suspended the municipal constitution of our ancient City, violating the Charters, spoiling the public records, and converting into a source of private patrimony, the revenues which had been granted for purposes of public utility and advantage.
