Pursuant to a Requisition from several of the principal inhabitants of Cartow and its vicinity, a meeting has been called by the Sovereign for Thursday next, to take into consideration the propriety of addressing his Majesty, and testifying their unshaken loyalty to his sacred person, and to the Constitution.

We learn that a Vote of Thanks has been passed, and is in progress of signature by the Gentlemen of the County of Limerick, to G. R. Fitzgerald, Esq. for his spirited conduct in the late attack upon Ward's house, the result of which must be of infinite service to the future peace of the County. Sir Fitzgerald was aided by his Nephew, Edmond Fitzgerald, Esq and deserves equal praise.

The late much lamented Paul Dawson, Esq. Surveyor-General of Customs, retired from his family on the evening of Friday last, apparently in perfect health, and next day, after a short illness, terminated his existence by the bursting of a blood vessel in the head.

Saturday morning, at an early hour, a party of the 4th Revenue Police, under the command of Lieutenant Breen, proceeded to the lands of Dromeliffe, County Clare, where they detected an extensive Distillery at full work which they destroyed, carrying away the vessels and spilling eight puncheons of potale, containing upwards of four hundred gallons.

On Sunday night, about nine o'clock, a party of about fifty men, well armed, attacked the dwelling-house of John Casey, of Tomdeely, within a quarter of a mile of the town of Askeaton, in search of arms, into which they fired several shots, and after breaking the doors, beat Casey's son in a desperate manner with the butts of muskets; they did not however succeed in getting arms at Casey's, but on retiring they took a gun from a dwelling adjoining. Several musket balls were found in the house next morning.

On Sunday night, an out office belonging to Daniel Gabbett, Esq. on the Ballinacurra Road, was broke open and a pair of cart wheels and some other articles stolen thereout.

On Monday last, an Inquest was taken by the Right Worshipful the Mayor, on view of the body of Joseph Gubbins, hatter, who was found hanging in his house, near Maddyke, the preceding evening. Verdict—"We find that the deceased did willfully put himself to death by hanging."—The Mayor ordered the body to be interred in unconsecrated ground.

A Boy of about five years old, was burned to death on Monday, in Mary-Street, his clothes having taken fire.

Sunday night last, a West Indianman, name unknown, laden chiefly with Demos, was driven ashore in Ross Bay, to the Northward of Loop-head, the Captain was lost at Sea—the remainder of the Crew, eleven in number, have been since landed in safety.
