Monday, upwards of 300 men of the Honourable East India Company's Artillery and Infantry, marched from Chatham to Gravesend, under the command of Major Somerville, to embark for India, as also a detachment of the 75th regiment. Last week, detachments of the 24th, 59th and 77th regiments, arrived at Chatham from the Isle of Wight. Detachments of the 46th, 47th, 65th and 67th regiments, and 11th and 13th Dragoons, marched to Gravesend last week, to embark for India.
