

impulse of duty and consistency. What number of respectable persons attended, it is not in my power for the Chapel was so intensely crowded that I had opportunity of distinguishing. I can however say that immediately around me were highly respectable, and as to the formality of calling it a County, as a City meeting, I do not recollect to have heard a single observation; and on the question of that formal explanation can I believe be given, by those interested themselves in convening the meeting.—I was informed that several respectable gentlemen were dispersed through the galleries; and, certainly the gentleman, Mr. Harrold, whom you well know and who sat in the Chair, is truly respectable; but this is to me a matter of comparative indifference. I will not profess my own, and I think every gentleman present (be their opinion on the question itself what it may) will do me the justice to say that I would not have been my interposition necessary, the slightest indiscretion, or irregularity. On the Ecclesiastical question which was originally presented to the public, I shall only say, that you with adverting to one clause, the effect of which is intelligible to every description of persons. A man selected to the situation of Bishop or Dean, by those who know him best, and who are already pledged by their allegiance to act in every respect as behoves good men; yet, when thus elected, he may be discarded, and be degraded upon the vague, indefinite, but serious charge of civil unfitness. His sensibility and character, as a Clergyman and loyal subject, are thus deeply wounded without fair trial, defence, or appeal, and perhaps some unfounded and malicious insinuations. This is, moreover, to be recorded in his Majesty's Court of Chancery, and thereby to exist as a perpetual stigma.—It is consistent with the upright spirit of British justice and the administration of law, and would not every meek and worthy man in fear and trembling, pending so arbitrary a trial? Yes, the meek and worthy would shrink from a trial, and the intriguer, the presumptuous, the unscrupulous, and the unprincipled, would be content as to character and religion, imposing upon and regarding himself the minion of some personage of influence, and soon jostle the meek and amiable Clergyman from the high and exalted station. When the character of the Priesthood would be thus gradually ruined, could their poor and numerous flocks remain unmoved by the change? Could the same unrelenting and unflinching zeal and superintendence over the moral and spiritual propriety of those under their spiritual care (which has done so powerfully contribute to the peace and tranquillity of Ireland,) be expected from men imbued only with the love of temporal and selfish interest. When on former occasions a relaxation of the Penal Laws took place without any previous restraint on the Clergy, surely no injury did accrue to the public weal—but the contrary. It is to my regret, that after ages of unrelenting persecution, the Laity be most unkind in the Laity not to go hand in hand with their Clergy, in endeavouring to obviate any thing which is injurious to them, and consequently to the vital interests of their religion; or that at the moment we were about to enjoy the blessings of constitutional and long sought for freedom, we should look on with indifference to the infliction of restraints upon our Clergy, tho' they were not seeking any participation of those advantages. I further felt the most fair and candid way was at once to express my objections to the Legislature, and not to withhold my assent until the matter was concluded, and thereby to give an erroneous impression that it altogether acquired the merit of our approbation. I am, however, expressing my sentiments on the Bill as it has been hitherto presented to the public, most sincerely grateful for the advantages it offers to the Laity, and confident that the Legislature will, with justice and wisdom, render it equally acceptable to the Clergy; but while I thus convey my own feelings and opinions, I can respect, though I may regret, the conscientious opinions of others.

In regard to a second meeting, I am not aware that either of a public or general nature took place, than the consideration of the proposed one was, I fancy, not to the declaration published by the Gentlemen who were read from the meeting in question.
