and where arms were not to be had, the banditti insisted on getting money to purchase fire-locks and ammunition.

Yesterday a Meeting of the Magistrates of the Eastern District, was held at Elton, the Hon. George Massy in the Chair, when it was resolved to apply to Government for a military force to be stationed in different parts of the district .-- Richard Wilcocks, Esq. attended the Meeting.

The outrages are fast increasing in the County of Kerry, notwithstanding the praiseworthy exertions of the Magistrates and Gentry. The house of E. Sealy, Esq. was deprived of a gun, and at Mr. Milward's, of Bally-Egan, another; the house of George Hilliard, Esq. of Billorough, was also attacked for arms, but it contained none. On Saturday night, there was a large assemblage near Castle-Island, and on Sunday morning, a notice, signed "General Rock," was posted on the Chapel door of Ballinegeragh, which was torn down by the Parish Priest, the Rev. Mr. M'Carthy, on which he commented in strong language; but it is feared without making little or no impression on the feelings of his auditory, so rapid is the spirit of outrage extending itself. So great is the alarm in that quarter of the

country that several Gentlemen residing in that neighbourhood, have gone into Listowel.

A large quantity of lead has been taken off the house of Fealview, near Listowel.

The post-man from Cahersiveen to Tralee was robbed of his mail on Saturday morning, at Glanbegh, by some fellows who carried off both his valisse and post bags

The disturbances in the vicinity of Mallow are far from having abated. The military force in the town of M llow has been augmented by the Staff of the North Cork Militia, consisting of about ninety-six effective men, which had received orders to march from Fermoy, their head-quarters, in the course of the last week.

Some of the farmers in the County of Cork, in the habit of going to that City with butter, have been sworn by those nightly miscreants to purchase and bring with them in their empty firkins one pound of gunpowder each, and under penulty of death, if they decline doing so.

On Wednesday morning last, as John Berry , a police constable from the barony of Duhallow, was proceeding from Cork, where he had been with prisoners from Mallow, he came up on the road, about six miles from that town, with three carmen, with whom he walked in company for some distance, when the three attacked and beat him most unmercifully, took from him his carbine and sword, with which they got clear off, notwithstanding his endeavours to get the country people to assist him in recovering them. A short time afterwards the post boy and a Dragoon, conveying the mail from Cork to Mallow, came to the spot, but could afford no assistance. The carmen were from the neighbourhood of Charleville.

At a Meeting of the Nobility, Magistrates, and Gentry of the Baronies of Fermoy and Condons and Clougibbons, and the country adjacent, held at the Court-House in Fermoy, on Saturday last, to take into consideration the state of the country, and to devise the best means of preserving the peace, the High Sheriff of the County of Cork in the Chair, the following Resolutions were agreed to :-

"1st---That a Petition be presented to Government, requesting, as the only efficient means of preserving the Peace of the Country, that the Provisions of the Insurrection Act, lately repealed, be immediately acted upon, the Peace Preservation Bill having been found, in the opiaion of the Meeting, in every instance (except when assisted by the Insurrection Act,) to be inefficient.

"2d---That it is expedient that the Magistrates should each in his respective District, call upon such Farmers and others as are willing, and adninister to them the Oath of Allegiance.

"3d --- That a number of respectable Persons be called upon in each District, and sworn in as pecial Constables.

"4th --- That a Subscription be entered into, or the purpose of obtaining private information. "5th --- That a Committee be appointed for the urpose of carrying into effect the above

The 33d regiment will embark at Cove for Jamaica about the 1st of December.

Two companies of the 3d Regiment of Foot Guards arrived at Maidstone, on Saturday se'nnight, from Plymouth; and on Monday morning following marched for Chatham, where they are to be stationed.

On Monday evening, a strong detachment of Captain Holohan's Revenue Corps, infantry and cavalry, arrived in this City, under his immediate command, with a quantity of illicit malt, two perfect stills, heads, and worms, and a quantity of vessels, the entire of which occupied six cars, which they detected in the vicinity of Glanomera, Co. Clare, and where they, in the morning, had destroyed upwards of ten thousand gallons of potale. On their way to this City, an extensive private distillery was detected, which was effectually destroyed. Captain Helahan's party marched out of town yesterday morning, with the appearance of a highly disciplined corps, and the appointments and soldier-like appearance of the men, evince a close attention on the part of the Officer in command. In the evening, however, we observed them return with as equally an extensive seizure as that which they had deposited here the preceding day.

On Saturday last, Mr. F. O'Shaughnessy Officer of Excise, stationed at Rathkeale, proceeded to the Wood of Cratlee, County of Clare, assisted by a party of the 79th foot, and there destroyed three very extensive distilleries, containing large quantities of Pot ale and Singlings, also destroyed 40 barrels of Malt in process, and seized 10 barrels dry malt which have been lodged in the Stores at Limerick.

The remains of Doctor Barrett, Vice Provost of Trinity College, Dublin, were interred on Monday, at Glasnevin Church; his Will is as follows :--- To his four Nieces, an Annuity of £25 each; £200 a-year for life to M'Alister the College head Porter; £100 a-year for life to his female attendant in College; the remainder of his property, supposed to exceed £70,000 he has bequeathed in trust to the revost, and the Rev. Bartholomew Lloyd, S. F. T. C. for Charitable purposes and without any specification.

The Rev. Samuel Jones, Rector of the Parish of Ardcanny, has generously and considerately, during the present depressed state of the markets, reduced his tythes to five shillings an acre -an example which, if followed by all the Beneficed Clergy, would tend most materially to the tranquillity of the country. The inhabitants of the Parishes of Ardcanny and Kildimo have conducted themselves peaceably and orderly, and the interference of a Magistrate was not nesessary in either Parishes since the disturbances commenced, which disgrace the other parts of this County.

Last night a fire broke out at Boherbuoy, which threatened destruction to the entire range, but by the timely attendance of the Royal Exchange Fire Engine, and the Firemen of the Establishment, it was subdued with a trifling
