How can we disclose our manner with our plan, and embody our mind and our passions within the narrow limits of a mere synoptical announcement? Besides, we should blush to follow in the track of an ordinary Journalist, who, incapable of eking out a path for himself, necessarily takes to the beaten ground, and " plods his weary way" in a-PROSPECTUS!
