The Rev. John Rogers read reasons for fasting and thanksgiving, for the current year; and the Synod enjoined their Members to observe the same, if at all possible, in the last week of November.

Circulars have been issued from the Commissioners recently appointed to inquire into the state of Education in Ireland. These Circulars are in the form of queries, twenty in number, and are spread out on an immense sheet of paper; blanks are left opposite the queries, to be filled up by the persons to whom the receipt is directed. The questions apply to most of the topics on which the Country desires information, viz .the number of Schools in each Parish -the number of pupils -the names of the Masters and Mistresses-the Funds from which they are supported-whether they are in connexion with the Kildare-street Association, with the Hibernian, the Baptist, or any other Societies-whether the Bible is a class-book, or the New Testament only -the version, whether the authorised or the Douay-the impediments which the system has received—the motives and objects of those impediments. This relates to the interference of the Catholic Clergy, in certain cases. The question of Proselytism is also put; and the titles of the books read at the different Schools are also demanded. The answers are to be returned on affidavit, to be taken before a Magistrate. The queries are directed to the Protestant Clergymen.

For the last two months the daily hire of good labourers has been twelve pence in Carlow, and ten pence for the worst ! Such is the accuracy of Mr. O'Connell's information !--- but he has been always so accessible to liars and tale-bearers, that he really seems to be the very personification of credulity !---Carlow Post.

The Marquis Downshire has arrived in Dublin from London.

The Earl of Kingston has arrived in Cork. The Earl of Ormond passed though here yesterday for Kilkenny.

The races of Gort which commence on Monday, are expected to afford much amusement, as several capital horses are entered for the four days running. The hospitable mansion of Loughcooter Castle, the magnificent seat o Viscount Gort, is receiving a vast circle of distinguished visitors; and the public Ball which will be at the Sessions house, on Tuesday, will display beauty and fashion. All the respectable lodgings in Gort are taken for the week, and from the arrangements made, it is thought that few scenes of amusement will afford more variety

of entertainment. This morning a Military Band left town, to remain at Loughcooter Castle the ensuing week.

The Marquis Carmarthen has arrived at Gort, and joined his regiment, the 10th Hussars.

Captain the Hon. George Ralph Abercromby, of the 3d Dragoon Guards, quartered in this City, was, on Tuesday, elected Representative in Parliament for the County of Clackmannon, North Britain. The Government of Canada is under Colonel

Burton. late M. P. Co. Clare; and the command of the troops there is vested in Sir P. Maitland. John M'Donnell, Esq. a young Gentleman from Ennis, is appointed private Secretary to

the Acting Governor of Sierra Leone. No Military Promotions appear in Tuesday's London Gazette.

The 15th Hussars who disembarked from England, are on their way from Waterford to be stationed in Cork.

The head-quarters of the 15th Hussars are to be fixed at Cork; and the head-quarters of the 3d Dragoon Guards are to remain at Caher.

The 7th Hussars were reviewed at Hounslow, on Tuesday, by the Duke of York, who approved highly of this superior corps.

On Wednesday evening, as a young lad, som to Patrick Hayes, Esq. was returning from his farm-house at Cragg, to the town of Abbeyfeale, he was attacked on the road by two men armed, each of whom presented a pistol, exclaiming he should never tell a story again; fortunately both missed fire, when the young man spurred his horse, and made off; the villains having cocked again, they fired after him without effect. The lad, however, did not proceed far, when he was again met by an unarmed man, who struck and beat him desperately with a stone, and would have probably murdered him had he been knocked off his horse. Three men of very suspicious appearance, have been taken up by the Police in Abbeyfeale, and lodged in Newcastle bridewell, charged with the above offence. On Sunday morning last an aged woman,

named Ann Riely, who was on her return from Dublin, where she was visiting two of her sons who are in the Rifle Brigade, was knocked down, and robbed of a bundle of clothes and some money on the high road near Patrick's-well, in this County, by a man named John Kennedy, who has been since discovered by the Police, and fully identified by her. The woman's skull was fractured, and she is now in the County Hospital, with little hope of recovery. Kennedy is committed to Jail, to abide his trial at

the approaching Assizes.

At the fair of Purt, on Monday, two factions who have of late indicated a turbulent spirit against the laws, by rioting and disturbing the peace at fairs in that neighbourhood, met, pursuant to regular notice, when it is probable several of each party would have fallen a sacrafice to their revengeful fury, were it not for the timely arrival of Alfred Furlong, Esq. from Newcastle, attended by Mr. Percy, Chief Constable, and a party of mounted Police, who, having co-operated with Major Grey and his party of the 2d Rifle Brigade, quartered in Abbeyfeale, fully succeeded in seizing on a great number of weapons mounted with iron, and other missiles, thereby prevented the parties from executing their murderous designs.

A second attempt was made by the Castlecomer colliers, on Thursday evening, to destroy the Ouncels at Fowlerton-Gate; one of the rioters was severely wounded in the shoulder by a policeman, a party of whom repulsed the colliers.

On Sunday evening last, Michael Mooney, & farmer from Banagher, was robbed of £2 by two fellows, near Plassy; one of them, James Tierney, has been apprehended by the Police.

A most lamentable accident occurred at Killaloe on Monday. A man of the name of Ryan, who had been making a hay-rick, slipped off-& pitchfork (with the iron part stuck in the ground) being placed near the rick, he fell on the handle, and it literally passed up into his body; he lingered in the most excruciating agony until yesterday, when death put a period to his sufferings.

On Wednesday afternoon, the Mayor held an inquest on the body of Richard Punch, who was found in a quarry-hole near Garryowen on Tuesday; it appeared that the unfortunate man went to bathe, and not knowing the depth of the place, and being ignorant of swimming, sunk, and was drowned. Verdict, Accidental death.

On Wednesday, in Change-lane, John Clampett, a slator, had his skull fractured by a blow of a saxe from another slator, named O'Meara--they had some words at the time, and the whole originated about four pence !--- Clampett was conveyed to the County Infirmary, where there are but slender hopes of his recovery --- O'Meara was apprehended a few minutes after the event by the Mayor, who lodged him in Jail.

Yesterday a scaffold fell at the Castle Barrack, and Thomas Lynch, a mason, who happened to be on it, at the time, had his side and head severely injured.

A few days ago an inhabitant of Patrickstreet, who left his desk unlocked, was robbed of nearly £150 in Bank notes, by a youngster, who is not yet apprehended.

This day, John Ryan and James Shaw, two notorious thieves, were detected in stealing wearing apparel, which were in a field drying at Rathbane; they are lodged in jail by the Mayor.

In consequence of a continuance of peace and quietness in this County, Mr. Blackburne, with the consent of the Magistrates, has adjourned the Sessions under the Insurrection Act, which was to be held on Monday next, to Tuesday, the 10th August; and at Six-Mile-Bridge to Wednesday, 11th August.
