## WEDNESDAY, FEBRUARY 23.

Monday night, an armed party of insurgents attacked several houses in the neighbourhood of Kildimo, barony of Kenry, County Limerick, beat the inmates, fired shots and threatened to put some persons to death for assisting the proprietors to till the lands, which had been taken up from defaulting tenants.

Last night, a farm-house was maliciously burned at Kilbreedy, near Stonehall, part of the estate of John Waller, Esq. of Castletown. The occupier had, a short time before, been flogged by a banditti, and several of the party charged with that offence are in jail.

Last night, a number of persons surrounded the house of Mr. William Bourke, of Ranasare, about two miles from Rathkeale, and, after putting that Gentleman on his knees and threatening to shoot him, demanded the production of a man named Downes, a land agent, who had stopped there for the purpose of collecting rents; after dragging him out of the house, they commenced beating him with all manner of weapons, and left him, to all appearance dead, in the dyke of the road; he, however, after their departure, crawled into the house, and lies there dangerously ill.

In consequence of an attempt to intimidate some new tenants who lately got into possession of lands, near Croom, there was a meeting of Magistrates held in Croom, yesterday, to investigate the affair, and they declared, from the Bench, their determination to use the most strenuque exertions, to punish any person who would dare disturb the peace in that neighbourhood. The following Magistrates attended: - Thomas P. Vokes, John Croker, Croom-Castle; David Roche, Rev. W. M. Fitz-Gerald, James D. Lyons, Rev. E. Croker, Col. Dickson, Henry Lyons, Geoffry Browning.

Within a mile of Portumna, on Thursday night last, a man named Kelly was attacked in his house, and killed with a blow of a stone, by his own brother-in-law. inquest was held and a verdict of wilful murder returned.

On Friday night, four houses were burned by a gang of ruffians, in the same district, near Stony-Island; and on Saturday night, twelve sheep, heavy in lamb, the property of P. Toughy, in the same townland, were tied with a rope, thrown into a bog-hole and drowned. These outrages are supposed to have resulted from taking farms from which the former occupiers were ejected.

On Thursday night, the dwelling house and out-offices at Grangue, near Ballynatten, County of Tipperary, the property of Richard Trench, Esq. were levelled to the ground. This house was lately in the possession of Callanan and Crotty, who, about ten days ago, were dispossessed in consequence of owing a heavy arrear of rent. It appears that on Thursday morning some persons went to look at the ground, and it is supposed that the house was levelled in order to prevent the land from being taken. On Monday night last, thirteen Hoggets, the property

of George Robbins, Esq. of Hymenstown, were entirely plucked of their Wool, and one killed on the lands of Castleblake, where they were at grass.

The son of Lieutenant Smart, Waterford Staff, was attacked by three armed men, near that City, on Thursday evening, who knocked him down, and stabbed him in four different places-the wounds are severe but not

Monday last, the Mayor held an inquest on Margaret Shaughnessy, who died that morning in the County Jail of a bilious fever-verdict accordingly. She was charged with robbery, for which her brother was transported last

A man named Thomas Browne was severely bit by a dog near Kilpeacon this week, and has been admitted to the County Infirmary.

A poor woman named Catherine Bateman fell down stairs in a house, in the Old Town, yesterday evening, app had her leg broken.

John Donovan was thrown from a horse, near Rossbrien, on Monday, by which his leg was broken.

Mr. Killaly's new road through the sand-hills at Miltown-Malbay, upon the verge of the ocean, from the new bridge he has lately built over the river Anna, at Cassino, will I a great improvement and ornament to the country. In removing the sand some days ago, to make the road, eight skeletons of human bodies have been found bedded about six feet deep in the sand, each enclosed in a sort of coffin, made of stone flags, the sides, head and foot, set on edge, with flags at bottom and covering; there is no inscription on the stones, nor any trace whatever when they were laid there-but it is supposed that in ancient times they were unfortunate sufferers by shipwreck, and it is not improbable that they were some of the crews of those ships of the Invincible Armada, who were dashed to pieces upon Spanish Point, near those sand-hills, in the reign of Queen Elizabeth. Yesterday, William Evans, mariner, was convicted

before the Mayor, and sentenced to fourteen days imprisonment, for refusing to go to sea with his vessel, contrary to ships articles.

This day, a most respectable Meeting was held in the County Grand Jury-Room, to hear a Deputation from the Parent Society for promoting Christianity among the Jews. The Mayor was called to the Chair, and the Rev. Messra, Murray, Hamilton, Shaw, Benn, and Wood, successively addressed the Meeting, A very gratifying Report was read, and a collection made, when several individuals became subscribers to the Society.

The reductions of the three Veteran Battalions and the two Veteran Companies are confidently spoken of, on account of their expense, &c. The 1st and 2d Veteran Battalions are in Ireland, and the 3d is in Jersey: the 1st Veteran Company is at Chatham, and the 2d Company is in the Isle of Man.
