The Right Hon. the Earl of Portarlington and suite, arrived in town yesterday evening, from his Lordship's seat, Emo-park, Queen's County, and this morning set off for the Lakes of Killarney, whose unrivalled, picturesque, and romantic beauties, are seen to most perfection in this month, in the fall of the yellow leaf.

General Sir William Parker Carroll, of the 18th, (Royal Irish,) has arrived in town for a few days on a visit to his friends.

We are extremely sorry to find that, amongst the killed at Rangoon, is Captain Rose of the 89th Regiment, brother to Mrs. Thomas Westropp, of Ross-hill. The death of this excellent officer is a source of great affliction to his family; for the last twenty years he had been on active service and had been severely wounded in an engagement with the Burmese last year,

The 2d Battalion of the 1st Royals, and the 45th, from Ceylon, have arrived at Rangoon.

By the last accounts, Brigadier M'Creagh was taking the Royals, and two native Regiments to reinforce Brigadier General Cotton. His Majesty's 59th Regiment was under orders to march at a minutes notice.

This day, seventy of the 10th Foot, under the command of Captain King, arrived here from Fermoy, on their way to Newport and Nenagh, to replace detachments of the S8th, ordered to Corfu.

The Diadem and Hope Transports will convey the first division of the 24th Regiment from Plymouth to Cork and then embark the 88th.

It is uncertain whether the 28th or 36th will return from Corfu. The 53d Regiment is ordered for garrison duty to

Portsmouth, and marched from Chatham on Monday. Detachments belonging to the 22d, 58th, 62d, and 63d Regiments of Foot, and the 3d Dragoon Guards, marched on Tuesday morning, from Westminster for Bristol, on route to Ireland.

The provisional Battalion, which has been formed at Portsmouth and placed under the command of Lieutenant-Colonel Keyth, consists of the following Depots, viz. 18th, 28th, 36th, 51st, 52d, 80th, 90th, and 95th Regiments of Infantry; the depot of the 32d Foot did form a part of the Battalion, but on the arrival of the Regiment at the Motherbank, from Corfu, the Depot was embarked, in order that it may proceed with the Regiment to Devonport. We have reason to believe, that the only change at present contemplated in the stations of the Depots abovementioned, is that of the 80th Foot, which will be ordered to Manchester.

The Officer commanding the depot of the 23d Foot, at Brecon, has received directions from the Adjutant-General, to station Recruiting Parties at Carmarthen and Haverfordwest.

The detachment of the Royal Staff Corps, stationed at Grenville, Lower Canada, has been reinforced by an addition of one company.

Monday the three squadrons of the 6th Dragoon Guards Carbineers, now in Piershill Barracks, were inspected and reviewed on Portobello Sands, by his Excellency Major-General the Hon. Sir R. W. O'Callaghan, Commander of the Forces in North Britain. The troops looked uncommonly well, and went through their various evolutions with great steadiness and precision.

Two Troops of the 10th Royal Hussars marched the 15th inst. from Exeter; one for Devonport, and the other for Truro.

The South Hants Militia are to assemble on the 28th inst. at Southampton.

Thomas Drury, Esq. is appointed Adjutant of the Radnor Militia, with the rank of Captain-and Joseph Mercer, Gent. Lieutenant in the 2d Lancasbire Militia. There are no Military Promotions in the London Gazette of Saturday.

The date of establishment of the three Veteran Companies which are to be raised for service in New South Wales is the 25th of September. The Officers are to receive the same pay as Cavalry Officers; and the men, all of whom must have served as Serjeants or Corporals, and be fit for actual service, will also receive the same rate of pay as Cavalry soldiers, in addition to their pension: the Companies are to consist of 50 men each, and will be detached from one another: their duty may be considered that of the Police: the Officers are to assemble at Chatham on the 25th instant, under the command of Lieutenant Colonel Sir A. Christian.
