The Recorder animadverted pointedly on the absence of the individuals summoned, and said that out of a panel of 38 names there were only 14 present, while of the Market Jury only 5 appeared out of 24 names. To give it the most gentle appellation, it was a very great disrespect to public justice, and if people did not aid its administration, they had only themselves to blame. The following were finally sworn on the Grand Jury :-Joseph Gabbett Bouchier, Esq. foreman, George Westropp Jamieson, Jeffrey Foote, Stephen Roche, Francis Philip Russell, James Kelly, John Arthur Meade, Wm. Hartigan, John Bold, John Rochford, James Ryan, James Alton, Joseph Delany, David Hunt, Henry White, James Ferguson, John Oliver O'Brien, Paul Erson, and William Fitzgerald, Esqrs. The Recorder said he could not discover on an inspec-

tion of the calendar, any particular charge which would render it necessary for him to detain the Members of the Grand Jury for any time. He would only, therefore, offer a few remarks. while congratulating them on the peaceable state of the City, in which the offences enumerated, though apparently numerous were trivial in their character, and such as might be expected in a large and populous community.

There happened to be one class of crime which militated strongly against the administration of the law, and which deserved their serious attention, he alluded to the practice of rescuing goods distrained for rent, and attacking the persons employed in the distress. If the great mass of the population once take the absurd notion into their heads, that they can successfully resist the due process of the law, and render nugatory its operation, such a state of things would endanger the very frame of society, and place the country in a most precarious conditionneither life or property would be secure. There was another subject of importance to touch on, which however did not immediately come within the sphere of their duties: it was the change of the currency. This measure the Jurors would be enabled from the stations which they respectively occupied, to explain to the ignorant portion of the population; and, to carry into effect the intention of the Legislature. Much of the mischief which may result from the non-arrival of the copper coin, can be checked by affording the useful information, that 13d. of the old copper must invariably represent the British shilling, and that any attempt to impose on the public by giving a less sum, will be punished by the Mayor, who will likewise order compensation to the complainant, for any loss of time suffered thereby. It was infinitely to be lamented, that a supply of the new copper currency had not been received, so as to obviate the inconveniences which have unavoidably arisen. The weights and measures enjoined by the recent Act of Parliament, which should have been in general use before now, have not arrived, owing to the disappointment experienced by the person who had contracted for them. The sum granted by the Assizes Grand Jury for this purpose was £50, but it proved inadequate, and the Mayor, on learning the circumstances, with a promptitude and liberality which distinguish his character, wrote to Mr. Gatchell, of Dublin, and desired him to order them immediately from the Treasury, and to draw on him for the amount, which will be near £200, for which he makes himself respon sible. Accordingly they may be expected in a very short

After the Grand Jury had retired, the following persons were sworn on the Market Jury :- John Goggin, John M'Namara, Edward Brown, John Brown, Robert Frost, Thomas M'Cormick, Charles M'Mahon, Patrick Grace, William Harte, Patrick O'Mealy, Richard Scott, and James Clanchy. The Recorder, in addressing the Market Jury, observed that they were furnished by his order with extracts of the Act of Parliament which relate to their duties, and he would recommend them to divide themselves into classes of two to each district of the City, which must give the population a greater advantage when their interference would be necessary for the reformation or punishment of any abuse or imposition, He wished to impress on them how essentially necessary it was, for the benefit of the lower orders, to examine minutely into the actual state of the markets, the provisions, and the weights and measures. As soon as it can possibly be effected, the new weights and measures will be procured and placed at their service, the Mayor having already done every thing in his power, and even more than could be expected to expedite them. Any obstacle which they might meet with in the discharge of their duties, he requested they would immediately apply to the same Chief Magistrate, whose pleasure it was to render them every aid and assistance for their support.

The latter personage, whose character is altogether above doubt. protested with stentorian eloquence his innocence, haking a very natural allusion to his hereditary profession, by which exalted but unenviable office, he very philosophically observed, many persons had died innocent .- " Finis coronat opus."

John Ryan, for stealing a shirt, the property of Patrick Downes, was sentenced to one month's imprisonment.

Martin Hayes, for stealing a bottle of spirits, the property of William M'Kenny, was sentenced to three anonths' imprisonment.

John Grady, for assaulting Ellen Grady, his wife, was not prosecuted, but a very aggravated prima facie case being made out against him, was ordered to find bail to keep the peace for seven years, and to stand committed until securities were entered into before the Mayor.
