GRAND MEETING OF THE ROMAN CATHOLICS OF MUNSTER.

HE following Resolutions were, unanimously adopted at a General Provincial Meeting of the Roman Catholics of the Province of Munster, held at the Catholic Cathedral, in the City of Waterford, on Monday, the 28th, and Tuesday, the 29th of August, 1826-WILLIAM ROCHE, Esq. of Limerick, in the Chair.

Moved by Dominick Ronayne, Esq. of Hingville, Co. Waterford, seconded by John Ryan, Esq. of Scarteen, County Limerick-" That the Rev. John Sheehan-a man no less distinguished by his active exertions in the cause of civil liberty as a citizen, than by his sealous performance of his sacred duties as a clergyman, be requested to act as Secretary to this Meeting."

Moved by Thomas Wyse, Esq. Manor of St. John, seconded by James Scully, Esq. of Tipperary-" That Catholic Emancipation is due to the People of Ireland from the Legislature, not as a matter of favour, but as an undoubted right, founded on the principle of Liberty of Conscience, and sanctioned by that social compact which in a free State guarantees an equal participation in civil privileges to all who equally contribute in blood and treasure to the support and maintenance of that State."

Moved by Mr. Secretary Coppinger, seconded by John Kelly, Esq. of Limerick-" That the Great Charter of British Liberty was wrung by a Catholic People, Clergy and Laity, from a narrow-minded and oppressive tyrant, and that Charter has consecrated those popular rights, which would be delusive and worthless, if, whilst they unchained the body, they left the mind in fetters, and placed conscience under the control of human oppression.'

Moved by John O'Brien, Esp of Elmvale, County Clare, seconded by John Scolly, Esq. Tipperary .-"That our title to Emancipation is further confirmed by the great National Compact, the Treaty of Limerick; Treaty fully and honourably fulfilled by the People of Ireland on their part, but which was most perfidiously and basely violated by the British Government of former times; and such baseness and perfidy are justly attributable to all those who continue to countenance and support such violation."

Moved by John O'Connell, Esq. of Grena, County Kerry, seconded by Thomas Dennehy, Esq. of Bellevue, County Cork .- " That the crime of withholding Catholic Emancipation is much enhanced by the pernicious consequences to all classes of his Majesty's subjects, Protestants as well as Catholics. It unjustly elevates the former, to depress with equal injustice the latter-it gives to a Party what should belong to the whole Nation -it substitutes the profession of opinion for the performance of civil duties-it creates jealousies-it corrupts the sources of justice-it poisons private society and contaminates public bodies-it impoverishes the Catholic and renders the Protestant insecure-and it perverts religion into a source of strife and hate, instead of being, as it ought to be, and as it was intended by its Divine Founder to be, the cement and bond of social order, and the sweet and endearing foundation of every private and public virtue, and of all the charities of domestic and social life.'

Moved by Patrick Power, of Bellevue, Esq. seconded by William Howley, of Limetek, Esq -" That it is an unworthy calumny, not credited even by those who give it circulation, that there is any thing in the principles or conduct of the Catholics to render them undeserving of Freedom. We hold no tenet inconsistent with liberty or with constitutional submission to civil authority. The British Constitution itself was framed and matured by Catholics-and we dismiss with contempt and scorn the absurd allegation, that Catholics, who instituted, are unfit to maintain that glorious Constitution."

Moved by Daniel O'Connell, Esq. of Derrinane, County Kerry, seconded by John Rocke, Esq. of Aghada, County Cork .- " That the conduct of the great majority of the Prelates of the Established Church, in opposing by all manner of means our Emancipation, deserves the deep reprobation of every friend of religion and social order. It is inconsistent with the principles of the Reformed Religion, in which they profess to believe, because that Religion purports to be founded on an appeal to individual judgment. It is equally inconsistent with their interests, as the necessary tendency of such conduct is to convert the submissive neutrality of the Catholics into active and zealous hostility, and to embitter the sense of injustice which the support of an opponent clergy naturally creates by superadding the sting of insult.
