The mail coach from Cork to this City, broke down on Sunday morning, a little beyond Mallow. The fore axletree gave way and brought the coach forward on the wheel horses, who plunged violently to extricate themselves, as the foot board pressed against their backs. In this emergency the driver contrived to keep his seat and held them in with great difficulty, until the passengers, most of whom leaped off at the first alarm, assisted in liberating the horses, and thus averted worse consequences. The mail-bags were sent on and arrived here at four o'clock in the evening, by a post-chaise, in care of the guard. The coach and passengers arrived soon after.

Daniel Meaher, mason, a native of Castle-Connell, was drowned by falling into the Long-Dock, late on Saturday night. The unfortunate man is supposed to have been in a state of intoxication when the accident occured. The body was discovered at an early hour next morning, when an inquest was held by the Mayor, and a verdict of accidental death returned.

Mr. Cox, Coroner, on Saturday, held an inquest at Broadford, near Mount Plummer, on the body of Connor Histon, who it appeared in evidence was killed at a quarry near Droumdeveen, by the bank falling in on him. Verdict, accidental death.

At Doone, in this County, about twelve o'clock on Sunday, two factions commenced a dreadful engagement and the result was, one man, Thady Kearney, killed, and another man, from Murroe, died on Monday, of a desperate beating inflicted by those savages, whose acts continue to reflect such disgrace on the country.

On Saturday, a man named John Lynch fractured the scull of a person named Patrick Walsh, by a blow of a

stone, in a fight at Abbington.

Monday a labouring man named Hickie, passing over a ditch near Ballysimon, slippped and fell upon a scythe which he had in his hand. He was dreadfully cut across the back, and his spine is seriously injured.

The Lord Lieutenant has been pleased to respite Nicholas Nugent, who was sentenced to death at Mayo

Assizes, till further pleasure.

On Thursday, a labouring man named Connor, was killed at Killarney, by a horse and car laden with timber, passing over his head.

At the fair of Ennis on Monday, there was a large show of cattle and sheep. The latter were in good demand. Some sales were effected in black cattle and at good prices.

At the fair of Connolly, County Clare, on Saturday, two factions met for the purpose of deciding an old quarrel, being well provided with fire-arms and scythes. All business was totally suspended, and rioting continued to a late hour in the evening.

The Florentia, Billett, from London, with 176 male convicts, for New South Wales, has put into Cove of

Cork.

The Marquess of Huntley, Ascough, from London, has arrived at Cove, to embark male convicts for New South Wales.

There are no convicts from the County or City of Limerick now in Cork, having been all forwarded in the last vessels.

The Lord Bishop of Waterford and Lismore has been pleased to present the Rev. C. H. Minchin to the Prebend of Kilgobinet, in the Diocese of Lismore, vacant by the resignation of the Hon, and Rev. George Bourke.

Judge Vandeleur has arrived on a visit at the seat of his brother, (the Right Hon. John Ormsby Vandeleur,) Kilrush, after concluding the Connaught Circuit.

Mr. Kingdom, Store Keeper, at Hawlbowling, near Cove, is appointed to the Dock-Yards, at Chatham, and

is to be replaced by Mr. Grant.

At a meeting of the Corporation of Kilkenny, held on Wednesday last, Thomas Neville, Esq was elected an Alderman, and on the same day, Henry Gore, Esq. Dr. L. C. Kinchela, W. H. Bracken, D. Recorder, and Ambrose Shearman, Esqrs. were elected Common Councilmen.

The best running ever known was seen at Mallow races, on Saturday—two distinct plates were won by Mr. A. G. Creagh, of Laurentinum, and Mr. Smyth. of Castle-Widenham. There was no running on Monday, in consequence of constant fighting between the country people, which attained such an alarming height, that a military force was sent for a distance of two miles. Several persons were seriously injured.

Tuam races commence on Monday, the 17th September,

two days after the Limerick meeting.

Sir Robert Shaw, Bart. and family, Lieut.-Colonel Grey, and Major Lord Arthur Hill, M. P. of the Scots' Greys, have arrived at Killarney, to visit the romantic and enchanting scenery of the Lakes, at this desirable season; also, the Hon. 
