

Lieut. General Sir John Byng, Commander of the Forces, commences his tour of inspection this week through Ireland.

The troops in garrison had a grand field-day this forenoon at Newcastle, preparatory to Sir John Byng's expected review.

Monday last the Mayor held an inquisition on William Kane, a baker, who died the previous night in consequence, it was represented, of drinking spirituous liquors to excess. Verdict, died by the bursting of a blood vessel. It appeared that the deceased with three others of his trade were nearly the entire of Sunday night at a public house, where they drank not only to the amount of what money they possessed, but also left part of their wearables for the reckoning.

Sunday evening, a fine young lad William M. Wilson, son of the late Henry Wilson, Esq. returning to town from his uncle's, fell down on the road and without any apparent previous indisposition, was deprived of life.

A sailor in one of the transport ships at Cove, bound to New South Wales, was drowned on Tuesday in that harbour: he had been refused to allow his wife to accompany him on the voyage, and resolved to desert the vessel by swimming to shore, in the attempt of which he perished within twenty yards of the beach, in presence of his wife, who had been waiting for him with a supply of dry clothes.

The attempt to assassinate Mr. Purefoy, as stated in our last, merely because he is a most excellent and independent Magistrate, has created a lively interest in the County Tipperary. We trust that such steps will be taken as will bring the conspirators to speedy justice.

The three children who observed the murder of William Dwyer, near Cappawhite, as detailed in Saturday's Chronicle, have been taken to Dublin by order of Government—their relation of the atrocious deed will no doubt lead to the detection and conviction of the perpetrators.

Thomas Orr, a private in the Sappers and Miners Corps, is lodged in Londonderry Gaol on a charge of killing Philip M'Loughlin, a Constable of that City.

A Court of Inquiry commenced at Boyle on Saturday, at which Lord Lifford, as Commissioner of Excise, presided. The object of the Court is to take into consideration the case of Lieutenant Kelly of the 3d Revenue Police, who had been removed from his situation in consequence of a charge having been preferred against him with respect to the non effective manner in which some malt was destroyed by him in the month of Sept. 1827. This inquiry, (at the solicitation of Mr. Kelly, has been instituted by order of the House of Commons) justly excites a good deal of interest.

Government have surrendered the Capal from Limerick to Killaloe to the Limerick Steam Navigation Company, who have appointed John Carroll, Esq. of this City, their Secretary.

Government are about to dispense with the services of the Directors-General of Inland Navigation, in consequence of the Newry and Limerick Canals, lately under their controul, having been assigned to private companies.

The Earl of Clare embarks this week for his Government of Bombay. His Lordship, we understand, proceeds overland, and expects to be at his destination about Christmas next. We sincerely wish him a safe and prosperous passage.
