SHOCKING FATALITY.

It becomes our duty to record one of the most painful and afflicting casulties, which society can be exposed to in this earthly stage of trial and vicissitude. The awful calamity has attracted more notice from the rank of the principal victim, and the noble and highly respectable family and connections who are thus suddenly involved in the greatest distress of mind.

On Sunday last, the Hon. William Massy, of Belmont, near Castleconnell, his Lady, the Hon. Mrs. Massy, and children, intended to dine with Sir Hugh Dillon Massy, Bart, at Doonass, on the opposite side of the river. Mrs. Massy and a man servant entered the cot and pushed off from the shore, while Mr. Massy returned to the house to answer a letter, accompanied by his two sons, meaning to -follow in the next trip across The river was covered by an exceedingly dense mist or fog, and the two cot-men soon lost sight of land, for the darkness augmented every moment and added to the danger. In this alarming crisis, ignorant of their exact route, though pulling in what was fancied the proper direction, the stream was rapidly drawing the bark towards that perilous and rocky precipice, well known as the Salmon Leap, over which the waters tumble in boiling agitation for a fall of several feet, and in one part perpendicular. They were perfectly invisible from either shore at this fatal moment, and imagination can only picture the horrors of their situation. It is certain the cot was irretrievably seized by the rapid current, hurried over the abyss in an instant, and engulphed in the foaming surge below with the hapless freight it bore.

Thus perished in the prime of life and the bloom of health the Hon. Mrs. William Massy, sister of John Smith Barry of Foata, County Cork, Esq. and the mother of three children, also John M'Namara, one of her servants, and two cot-men,

brothers, of the name of Hewett.

None of the bodies are yet found, although every exertion is being made each day since for that purpose, by a number of boats dragging, on the river. We must avoid any allusion to the state of mind of the Hon. Mr. Massy, the unhappy consort of this much lamented Lady. The only relic found after the dreadful accident, was a small trunk belonging to Mrst Massy, which was seen floating on the water, and contained some articles of dress. The cot was staved to

The Hon. William Massy and his brother, Major Massy, passed over to Doonass, in the evening, in a second cot, and then only were they apprised of the harrowing scene which had been enacted.

P. S. We have this afternoon heard that the body of the Butler is discovered.
