Monday last, a General Court-Martial assembled at Ennis' for the trial of Major Cadell, of the 28th Regiment of Infantry .- President : Major-General Sir G. R. Bingham, K C. B. Members: Lieutenant-Colonels Mein, 74th RegiBARBAROUS OUTRAGE AND MURDER.

On Sunday night week, the 7th instant, the house of an industrious young man named James Doherty, of Shanaclough, near Ulla, in this County, was attacked by a party of persons, who upon breaking in the door, rushed to his bed side, and fractured his scull in a dreadful manner, stabbed him in two places in the left side, and also in the right arm; all resistance was vain, the ill-fated young man was overpowered, and his servant boy, Thomas Magrath, had his arm broken. Doherty never spoke after, lingered in an insensible state until Thursday, the 11th when he died. Three women who were in the house say they do not know any of the people who came in." At the Inquest on the body, held by Jumes Bennett, Esq. Coroner, on Saturday last, these three women refused to give any evidence-they have been since committed to the County Jail for further examination. Various causes are assigned for this brutal mucher, but it is confidently hoped, the outraged laws will be vindicated in this as well as every other similar instance, which it has fallen to our let to record for some years past in this County.

Robert Bemrose, Master and Serjeant of the band of the 76th Regiment, in this garrison was found dead on Monday evening at his lodgings in Roden-lane, convenient to the New Barracks. The deceased man was unfortunately addicted to irregular habits of living, and under the pernicious influence of a debauch, fastened himself by the neck from the roof of the bed, and thus died of strangulation. The wife had previously left the bed-room at his request, and taken out the children, requesting her hashand, who was much agitated, to take some rest. In her absence the fatal deed was committed; she returned in half an hour, but he was then being cut down quite senseless. The Mayor held an inquest on the body yesterday morning. Verdict-Temporary derangement.

Monday, the Mayor held an inquest at the County Infirmary on the body of Luke Gleeson, of Ballineguard, who died in that Institution the previous day of fracture on the head. It appeared in evidence that so late as the 31st of May last, he received a blow of a stone on the head at the fair of Glenogra, for which wound he was brought into Hospital, and languished until Sunday last. Verdict-Wil-

Constantine Smith, the Pensioner, whose attempted assassination we mentioned in our last, is not dead. He lies dungerously wounded at the residence of Mr. Vokes, where he receives the most humane attention and eminent professional atundance.

The Terry Alt system is not well extisted in the neighbourhood of Broadford. Three or four months since the wife and family of the Rev. William Butler's steward were obliged to abandon their house, because the husband had proved himself a rie and faithful servant. The persecuted man erroneously thinking the insurrectionary system had passed over, resolved to send for his family, and with that view built up a rick of turf convenient to the house, for their use. Saturday night, however, the pile of turf was observed in flames, but the malicious purpose of the incendiaries was not accomplished, as Captain Campbell's detachment of the 74th Regiment immediately turned out and assisted in getting down the conflagration. "Had the wind been from the opposite quarter, the steward's dwelling-house would have been consumed. Mr. Butler had it confidentially from a gentleman a short time before, that the first new outrage to be committed in the barony would be against his steward.

Two persons named Kennedy, against whom there had been informations, for being concerned in the Police murder some time ago at Doolan, County Clare, were arrested on Thursday last on board a ship off Black-head, in the bay of Galway, which was about to sail for America; and also a third person named Macheen, charged with the murder of a man named Moloney, near Cratloe. The three were taken by Serjeant Moran, of the County Galway constabulary, and by him transmitted to Eunis Gaol. A fourth fellow named Barry, charged with the murder of Mr. Blood, was on Monday taken on board a vessel in Galway, which is also destined for America.

A letter to our Office from Cashel, dated yesterday, states & -On Thursday last, the 11th instant, while a party of Police (twelve in number) who were ordered by Mr. Fitzgerald, Chief Magistrate, to protect three men of Archdeacon Cotton's, valuing Titlies at Luke near Thurles, were attacked by a mob of about 200 persons, who appeared very determined not to allow the Valuators to proceed, and were consequently obliged to retire on the Police for protection; after the mob persisted (but to no use) for the Valuators to be given up to them, the Police were obliged to prime and load, in order to effect a safe retreut.

Up to a late hour on Saturday no person had been arrested for any of the three murders committed within the last few
