

solved, and that the population... policy of yielding to the ordinary authority of the laws. He would advise them to reflect on the enormity of the crime they had committed, and he trusted that the bountiful mercy of his Majesty would prepare them to atone in time for that tribunal which was yet to pronounce on their guilt. His Lordship then sentenced them to execution on the 6th of April instant, but he said it would be respited.

George Meade was indicted for the murder of Serjeant James Robinson, 5th Regiment, at Cloudegad, then withdrew his plea of not guilty, and pleaded guilty.

Mr. Bennett said he felt justified in acceding to the proposition. Two examples have been already made for this crime, a great number were concerned in the murder, and he believed the prisoner was one who unguardedly joined an unlawful confederation. He hoped the prisoner would feel a proper and sincere contrition for this clemency. He understood the prisoner was not a promoter or inciter to the attack, and he would intercede with the Lord Lieutenant for a pardon to save his life, but which must of course involve any commutation of sentence Government may think advisable.

Judge Moore said the withdrawal of the prisoner's plea was a proof of submission to the law, and admission of his guilt. He expected it would make a salutary impression on his confederates. His Lordship pronounced sentence of death for the 6th of April, which he said would be also respited by authority of the Court.

Judge Jebb now withdrew to preside in the other Court.

Molony, who was acquitted on Monday for the murder of John Glyn, will be tried to-morrow for conspiracy to murder.

No day is fixed for the departure of the Lord Lieutenant from Dublin; his stay in England will not exceed a fortnight.

The Postmastership of Ennis is still vacant. The Breeze and Priscilla, which dropped down the River yesterday for Quebec, have nearly 500 passengers, mostly composed of retired military officers who have obtained government grants of lands, and farmers of proper conduct and their families, abdicating the disturbed districts where neither their lives nor limited properties were looked on by them, as secure.

On Thursday last, a Steeple Chase was run from Bally-daniel to Mount Plummer, over a most sporting country, between Mr. Fitzgerald's mare Flirt, and Mr. James Massey's mare, Cracked Moll, rode by the owners. The latter set off at a killing pace, and seemed determined to go but was soon overtaken by Flirt, who took the lead, and kept it to the winning post, coming in good style. The day was fine, and the country in first-rate order.

Yesterday, Lieut. Bowerman and his party of the Revenue Police, destroyed a quantity of malt and potale, and seized four illicit stills at work near Meelick; conveying them to the King's Stores they were attacked by a mob near Bank Place, who attempted a rescue, but the determined conduct of the party prevented their design, and one of the ring-leaders was this day convicted at the Petty Sessions, and sent to the Tread-mill for one month.
