We have the satisfaction of saying the disease has abated materially of its virulence, and the cases now in hospital are of a much lighter shade than those of the previous week, and the symptoms more favourable.

We regret to learn there is an increase of Cholera cases among the 27th Regiment in the New Barracks, and that

two soldiers died of the epidemic since Saturday. Another soldier of the 27th Regiment, named Fitzpatrick, died yesterday of Cholera, and was privately removed from the barracks in a close-covered waggon for interment in Munchin's Church-yard. No military escort or funeral honours are paid on those occasions.

Official report of Cholera in Ennis, June 26th, 12 cases remaining yesterday, 2 new cases, 2 deaths, 4 recoveries, and only 8 remaining in Hospital. Extern cases, 4 remaining last day, 3 new cases, no deaths, 2 recoveries, 5 re-

maining. The accounts this morning from Ennis of the Cholera are

still more favourable than yesterday.

State of the Cholera in Ennis to one this afternoon-13 cases remaining yesterday, 7 new cases, 2 deaths, 5 recoveries, and 13 remaining in hospital-Total cases 255; Total deaths, 140.

Saturday there was but five deaths of the Cholera in Cork, and 15 new cases.

The Cholera accounts from Cork yesterday are gratifying, -only two deaths, 13 new cases, and 37 recoveries. There was no death at Kinsale on Sunday or Monday.

The Duke of Devonshire has given another sum of £50 to the Relief Fund at Bandon, where the disorder is light.

There was no death of Cholera at Tralec on Saturday, and but one new case. Last Saturday there was but one death of Cholera in

Galway, and eight new cases. The Cholera has made its appearance at Castlebar, where

the Board of Health have opened an Hospital. The Quarter Sessions of Ballinrobe are adjourned to the 27th of July, in consequence of cholera raging there.

A clergyman of the Established Church, tutor in a gentleman's family near Doneraile, died there on Friday of Cholera. He was privately interred near the house, as the people of the neighbourhood rose in a body, and would not allow his remains burial in consecrated ground.

The Thurles Board of Health have received, from the Consolidated Fund, Two Hundred Pounds, for the purpose of fitting up an Hospital, and using every means necessary to meet the Cholera, should it unfortunately visit that town.

In order to guard against the introduction of Cholera, the Board of Health of Waterford have given directions that the Gipsy steamer, on her arrival from Liverpool, shall remain in the middle of the river until examined by a medical man, and that no person shall quit said vessel, until after such examination.

The fatal cholera has appeared in Clonnel. Mr. Patrick Parlo, lock-smith, formerly of High-street, Waterford, was the first victim. There was not the least doubt among the medical men that the case was one of decided cholera. Another person residing in Parle's house, was attacked on Thursday, and died that night; and on the same evening, another man in the suburbs, at the county Waterford side, sunk under this unsparing malady. The infected bouse, where the disease first appeared, is frequented by guards, and drivers, and the humbler description of travellers.

The Mayor of Clonmel called a public meeting on Saturday, to divide the town into districts, and appoint superin-

Tipperary, Tuesday evening-"We had 18 cases of tending visitors. Cholera here, 13 fatal; the hospital at present empty, and I have not heard of any case these two days, with the exception of one buried last night; this morning none."
