

Yesterday the Cholera return for Cork gave nineteen new cases, and 5 deaths, 13 recoveries, 115 remaining. There is no case of Cholera at Cove or Bandon.

Cholera has visited the Isles of Arran, where three deaths have taken place. There is not a Medical man in the three large islands.

There were six new cholera cases at Tralee yesterday, no death, remained in hospital 14.

There has been no new case of cholera in the 68th Regiment since their encampment near Clare Castle.

CHOLERA IN ENNIS AND CLARE.

Wednesday.—Three new cases are reported to-day, and one death, leaving under treatment twelve persons. Total cases, 289, deaths, 142.

As a proof of the necessity of immediate application for Medical relief, we think it right to refer to the death of Sergeant Brennan, of the Police—a powerful athletic man.—The consequence was, he did not submit until he was seized with spasms, and was brought to the Hospital at a time when medicine could not cure, and human aid scarcely alleviate his sufferings.

Thursday.—The report from Clare this morning gives two new cases.—We regret to learn that the wives of soldiers of the 68th, who remained in the village, have taken the disease.

The new cases in Hospital since yesterday morning are eight, three deaths, and 5 cured.

The cases of cholera in Kilrush were 45, and the deaths 27. The people are beginning to leave the town, so alarmed are they at the spreading of the disease.

We regret to have to state the death of Mrs. Molony, at the house of her son, the Chief Magistrate, at Gort. A Lady much esteemed and respected. The cholera is increasing rapidly in Gort.

The deaths on Thursday in Ennis were 3, and 11 new cases.

We are concerned to find the Cholera at Scariff, where its very name has spread the greatest alarm. Six cases proved fatal there. At the interment of one of the bodies which was conveyed from Scariff to Tomgrany, the people commenced a most disgraceful battle, which was kept up in the Church-yard until the deceased was covered up. The residents of Tomgrany did not wish to have a Cholera patient buried near them.

There has been no new case of Cholera at Lahinch the entire of this week.

We are happy in being enabled to give an authentic return of the progress of Cholera in the 68th Regiment at Clare, from the commencement up to yesterday. No death has occurred since the 21st June, and no case was received into Hospital since the 29th ult. when a soldier from Kilrush was admitted and recovered. None in hospital at present—recovered one officer, 78 soldiers, 16 soldiers wives, 5 soldiers children, total 100—deaths, one officer, one officer's wife, 18 soldiers, 2 children, total deaths 22—total cases, 2 officers, one officer's wife, 96 soldiers, 16 soldiers wives, 7 children—total cases, 122.

The whole of the 68th Light Infantry, two small detachments excepted, are now in camp near Clare.

The 83d Regiment is now encamped outside Castlebar, on account of Cholera in the town.

The Queen's Bays were inspected at Edinburgh on Saturday, and made a splendid display.

The Hon. Charles Grey, son of the Premier, and late Major 60th Rifles, is elected M. P. for Weycombe.

Lord Ingestrie is appointed Colonel of the Saffordshire Militia, vice Lord Waterpark resigned.

The Quarter-Master Serjeant of the 92d Highlanders died of cholera at Fermoy.

On Tuesday evening, Serjeant James Ryan, Drum-Major of the 27th Regiment, at Fermoy barracks, shot himself. The instrument of destruction was a soldier's musket. It is thought pecuniary embarrassment was the cause of this fatal act.

Yesterday a quantity of ammunition was removed from Clare Castle to this garrison under a convoy of the 68th Regiment.

The appointment of Doctor W. Renny, son of the Director-General of hospitals in Ireland, which appears in the last Gazette is the first that has taken place in the medical department of the line since August, 1828—During the intermediate period, all vacancies have been filled up from the half-pay list. This regulation was first enforced by the Duke of Wellington.

The Lord Bishop of Derry gave a dinner to 150 of his tenantry at Strabane, his Lordship presiding.

A prosecution by the Crown against Mr. Gubbins, of Knocklong, for breach of the game laws, failed this week, in the Court of Exchequer. It was sought to recover £20 penalty for shooting wild duck.

The merchants and land-owners of Mayo have petitioned Parliament to appoint flax inspectors in Ireland, and not to reduce the duty on hemp, as it must ruin the coarse linen manufacture.

TITHES.

At a numerous and respectable Meeting of PARISHIONERS of BRUREE and COLEMAN'S in this County, attended by the population of the surrounding Parishes to the number of several thousands,—at the Fair-green of Bruree, on Monday, the 2d of July, PATRICK O'SHAUGHNESSY, Esq. in the Chair, the following Resolutions were unanimously adopted:—

Resolved—That we forthwith Petition both Houses of Parliament for the total abolition of Tithes in this County, as productive of strife and bloodshed, discouraging agriculture, baneful to industry, and eminently hurtful to the best interests of religion.

Resolved—That seeing tithes in this country cannot be collected but under terror of the bayonet, it is high time that some other mode of remuneration for the services of the Clergy of the Established Church should be substituted.

Resolved—That such remuneration can be fully obtained by an equitable distribution of Church lands, which clearly ascertained to be more than equivalent to the support of the Protestant Clergy, from the highest to the lowest functionary.

Proposed by Michael O'Brien, Esq. seconded by Cagney, Esq.

Resolved—That we are determined in future by peaceable and legal means to oppose the exaction of an impost that we hold to be utterly unjust in principle and from melancholy experience we know to be cruel and vexatious in its operations.

Proposed by the Rev. J. O'Regan, P.P. seconded by Mr. Martin Carroll.

Resolved—That the thanks of this meeting are eminently due, and hereby tendered to that illustrious Prelate the Right Rev. Dr. Doyle, whose clear and energetic direction directed the first judicious application of the great principle of public opinion, to that overgrown mass of injustice, intolerance, and bad feeling,—the iniquitous tithe system.

Proposed by William Fosbery, Esq. of Ashgrove, seconded by Mr. Daniel O'Brien, of Dromore,

That, as all law was originally designed to promote public utility, the moral obligation of every law ceases to exist as soon as it is found no longer available to the advantage of the Commonwealth.

Proposed by Michael Potter, Esq. of Spring-Lodge, seconded by Mr. J. Sheehy, of Court,

That, although it is the conviction of this Meeting, no man is bound, in conscience, to obey a Law, which is evidently opposed to the good of the Public; yet, it is equally our conviction, the only justifiable, as well as the most cautious means of resisting any such injurious Statute those which have already been adopted with so much success in other parts of the Kingdom; namely,—Refusing obedience, and passively suffering the consequences.

Proposed by the Rev. Mr. Rieves, V.P. seconded by Thomas Boland, Court,

That, the imposition called Tithes, by which Roman Catholics are compelled to yield a tenth of their Labour, and Capital, to the Ministers of the Protestant Church, is from promoting the public advantage, is highly detrimental thereto, and that it is the duty of every member of the Community, by every legal means within his reach, to resist payment of the said impost, and to use his utmost exertions to procure its total abolition.

That, in conformity with the above Resolutions, it is the determination of this meeting from henceforth never to pay Tithes in Cash; and that as long as these unjust and oppressive laws exist, it is also our determination to resist the collection of them in any other way, by every means in
