Every one without distinction esteemed him while living, and the same general sympathy followed his remains to the grave-yard, at Kilmaley, on Friday morning. This general expression of regret may be said to be a poor offering of consolation to his afflicted young wife and family,-yet it must be a consolation, however, to them, that his career, though a short one, bore promise of future fame, and that while he was suffered to remain as a candidate for public favor, he earned in a few months what others have for years toiled in vain for. To his attendance in the cholera hospitals, and here subsequently, we may attribute his death .- Clare Journal.
