The Commissioners of the Admiralty have noticed to Half-pay Officers, and Officers' Widows, that in future they will receive their Half-pay due every quarter, upon application to the Collector on or after the 7th October, 7th April, 7th July, and 7th January.

In consequence of a remonstrance from the Cork Chamber of Commerce, the Commissioners of Customs have determined not to allow, without farther enquiry, foreign provisions into use so as to injure the Irish Trade.

Doctor H. O'pen is elected a Physician of the Cork general Dispensary.

Information having been received that a large assemblage of the peasantry was to have been held in the neighbourhood of Kinsale, on Sunday last, the Messenger Government Steamer, was promptly despatched from Cove with a detachment of Marines, which arrived in Kinsale harbour at ten o'clock on Sunday morning.

A meeting was held on Monday at Hollymount, for the purpose of marking out the site, and laying the foundation of an Agricultural School for the province of Connaught on a grant of land near that village. The business was opened by an address from Mr. Hyett—It is the intention of the London Trustees to provide a suitable outfit of stock and implements.

There was a good show of fat cattle at the Fair of Rathkeale on Monday; but the weather was most unfavourable for the attendance of buyers, and the business done was trifling.

At Boyle Sessions on Monday the Magistrates fined an inhabitant 10s for removing a printed notice affixed to his house by the Board of Health, signifying that a person had died there of Cholera.

MALICIOUS BURNING—On Friday night last a new slate house, containing about three ton of hay, the property of Mr. William Loughrey, Barrack Sergeant, was maliciously set on fire and consumed, at Brinkle, adjoining the military barracks, and within one mile of Parsonstown,—the work, no doubt, of some lawless incendiary; and were it not for Captain Smith, Barrack-master, whose unwearied exertions were manifested on this occasion, and to whom too much praise cannot be given,—aided and assisted by the Officers and men of the 64th Regiment, who displayed every zeal and efficiency in extinguishing the fire, the whole village, in all probability, would have suffered materially, as the flames were beginning to extend their ravages to the adjoining houses.

Friday, a sailor-boy of the name of Evans, fell from the main-yard of the Atlas brig, at the end of the Shannon-quay, and his brains were dashed out on the coping-stone.

At Milltown fair, Kerry, held on Thursday, cattle of every description fetched high prices.

In the Sheriff's Court, Ballymena, Mrs. Sarah Boyd has been awarded £100 damages against Samuel M'Cord, a farmer, for seducing her daughter.

Miss Green, of Newport, County Tipperary, died suddenly on Monday. There was an inquest on the body—Verdict, that she died by the visitation of God.

A girl, about 17 years of age, named O'Brien, was, some day, about a twelvemonth since, gathering health, on a bog, on the neighbouring mountains of the county Waterford; she imagined that she received a stroke of a sod,—so powerful did the idea work on her, that nothing could efface it,—her spirits drooped; she lost her vivacity, and at length verged into a pthisis of so confirmed a character, that she was only relieved from her sufferings by death! The female was buried on Wednesday evening last.

Saturday, Sunday, and Monday last, the weather was most inauspicious for harvest work; incessant heavy rains, which prostrated whole fields of corn.

The crops in the County Cork of Wheat and white Oats have suffered so considerably in many places from blight or lightning, that the Farmers calculate on their not yielding above half of an ordinary crop.
