The candidates for the representation of Belfast, are Lord Arthur Chichester, Wm. Sharman Crawford, and Robert J. Tennent, Esqrs.; another candidate is confidently spoken of but not named. The Hon. Col. Pakenham has been solicited to offer himself, but he has declined.

Lords Tullamore and Oxmantown have commenced an active canvass for the King's County, under very favourable auspices.

Thomas S. Harvey is appointed Agent to the West of England Insurance Office at Waterford, vice William Lumsden.

The Conservatives are determined to re-elect Mr. Shaw for Dublin, and a second Protestant Member if possible.—The freemen of Dublin are 5000, of which number the Guild of Merchants includes 1500.

Dr. Macartney, Professor of Anatomy in Trinity College, will be nominated by a number of the electors for the representation of that University.

The situation of King's Professor of Medicine in Dunn's Hospital, Dublin, vacant by the death of Dr. Leahy, will be filled up the 18th December next, by election.

A situation in the Medical Staff of the County Infirmary is vacant by the death of Dr. Grogan of this City.

The Earl of Shrewsbury has given £50 to the Wexford Fever Hospital.

The proceedings of the latest meeting of the Irish Conservative Society are amply detailed in first page; the receipts of the Society now average £800 a week.

Two cows were sold for tythes in Tralee this week, under protection of a company of the 32d Regiment.

On Wednesday night the house of J. Meade, a dairyman, near Caherconlish, was entered and robbed of two firkins of butter.

Six farm-houses were destroyed by fire at Kilmacthomas, near Waterford, this week.

An unfortunate man was killed on Friday night, on his return from Tipperary, in consequence of coming in contact with a young horse, which a horse-rider of the name of Begley was riding at the time; the horse came with such force against the unfortunate man that he was instantly killed. At the inquest a verdict of Accidental Death was returned.

Honora Ahern was committed to the City Gaol on Wednesday night, for stabbing with a knife Catherine Regan in old Clare-street, where the prisoner keeps a huxter shop, and after a dispute with the other woman about an old debt, which led to a personal assault, the prisoner ran back into her shop, and seizing a bread knife stabbed Catherine Regan thrice, inflicting severe, but, it is hoped, not dangerous wounds on her person. This day the Magistrates ordered informations against the prisoner.
