

The Mayor held three Inquisitions since our last, upon Saturday, Sunday, and Monday. The first was upon the body of Patrick Ryan, a country labourer, who died in the County Infirmary from the effects of a blow on the head with a rake, inflicted some weeks before by James Ryan, of Bohergar, while employed in saving hay. The second was at Barrington's Hospital, upon the body of John Poyntz, mariner, of the Camilla merchantman, in this port, Collins, master, who dropped dead on Saturday evening last, in Patrick-street. He had been previously, it appears, in bad health, and on examination of the intestines by Surgeon Franklin, it was found that the young man had died of hydrothorax. The last inquest was upon the body of John Ryan, corn-broker, who was found dead in a public-house in Pennywell, late on Saturday night, where he had been drinking undiluted spirits with other persons, and it appeared he died of apoplexy induced by intoxication.

John Bateman, farmer, and his wife returning from market on Saturday night, were attacked by three fellows in Clare-street, who robbed them of several articles of wearing apparel. One of the offenders, named Meyers, is in custody.

Six fellows were sent to the House of Correction for drunkenness and rioting in the streets on Sunday.

Laurence Cunningham, a mason, was murdered on Wednesday at Drogheda, by Philip Cunningham, a butcher, who stabbed him to the heart with a knife.

R. White, Esq. of Ballyholme, with a pilot and two seamen, were fined £100 each last week, by the Magistracy of Bangor, for being discovered in a sail-boat containing foreign spirits. They were committed to prison in default of payment.

On Tuesday night, as Surgeon Thomas Abernethy, Medical Superintendent of the Union Dispensary at Aghada, Cork, was returning from Trabolgan, he was thrown from his horse and killed on the spot. By this melancholy event the inhabitants of Aghada have lost the medical aid of this talented and respected young man.

On Saturday, as Mr. Guinness, of Dublin, the agent of Captain Malone, of Barrowstown, county of Westmeath, was returning from Banagher, (where he had been receiving rents,) in a gig, to Coghlan Castle, the seat of Captain O'Moore, he was fired at from behind a hedge with a blunderbuss; three slugs lodged in his head; and several passed through his hat. Although he is not declared out of danger, hopes are entertained of his recovery.
