The Right Hon. Henry Hartstonge Pery, Lord Glentworth, eldest son and heir to the Earl of Limerick, died rather suddenly at the hotel of Killaloe, at a late hour on Wednesday night last, of dropsical affection in the chest, under the incipient stages of which disease his Lordship had visibly laboured for a week previous, although no immediate fears were then entertained for the deceased Nobleman's life. Lord Glentworth was born the 26th of May, 1789, and had consequently attained the 45th year of his age, when death called him away from this life. He married at the early age of nineteen, the 11th of May, 1808, Annabella, daughter of Tennison Edwards, Esq. of Oldcourt, Wicklow, by whom he has left issue eight children, four sons and an equal number of daughters, viz.—Edmund Henry, named after his paternal grandfather, William Henry Tennison, John Hartstonge, and Henry Frederick; Annabella Erina, Mary Georgiana, Emily Caroline, and Cecilia Annabella. Lord Glentworth was formerly a candidate for the representation of the City of Limerick, having stood a contested election in 1812, with the present Viscount Gort, then Right Hon. Chas. Vereker, who succeeded by a large majority. By the death of his father, the Hon. Edmund Henry Pery, late a Captain in the 7th Royal Fusileers, and now Baron Glentworth, becomes heir presumptive to the title and estates of the Earl of Limerick. The late nobleman was possessed of many noble and generous qualities, an open and confiding nature, that involved him in serious pecuniary difficulties, and which have embittered the latter years of his life, having made himself partially a stranger to his numerous family, scarce one of whom has yet heard the fate of their unhappy relative. His Lordship's remains will be interred at the Cathedral. The prevalent feeling in this City upon the demise of Lord Glentworth, is one of general and undissembled regret.

A Life Commissionership of St. Michael's Parish is vacant by the death of Lord Glentworth.
