We are truly gratified to announce that George Vincent, Esq. son of the Rev. George Vincent, of Shanagolden, in this County, has been promoted by the Chief of the Admiralty, Lord Auckland, to the rank of Lieutenant in the Royal Navy, after holding the station of Midshipman for 21 years, 14 of which passed in active service affoat. He returned lately in the Brittania, from the Mediterranean, which was paid off. The flattering testimonials of the several distinguished officers this gentleman served under, have at length rendered an act of tardy justice to Mr. Vincent's merits.

At a late hour on Thursday night, or rather yesterday morning, Martin Meyers, a boatman, in the employ of Mr. Doherty of Ballinacally, county Clare, retiring to his boat at Arthur's-quay, after drinking freely, fell into the river and was drowned. The body was recovered soon after, but his fellow-boatmen sailed away with it before an inquest could be held.

John Molony, the alleged principal in the murder of Thomas Hartigan, at Ballineety, last Sunday evening, has for the present absconded, after a long and harassing pursuit by Sub-Constable Ahern of the Police of Ballineety.

Saturday night last a man named Conolly Egan, on his way home, was so violently beaten by four men with whom he had been drinking in Ennis that he was unable to reach his house until Sunday morning, when, having complained to his wife of the severe beating he got and showed the parts that had been injured, he stretched on his bed and continued in great agony until evening, when he expired. An inquest was held by Thomas Whitestone, Esq. Coroner. The persons who committed this outrage being known to the police, three of them named Patrick Clune, John Flynn, and Connor Flynn, have been arrested.

Tuesday morning between the hours of two and three o'clock, while the inmates were asleep, the dwelling-house of Patrick Costello, of Paradise, County Clare, was maliciously set fire to and burned to the ground. The inmates did not observe the fire until part of the roof fell in.
