A violent attack was made on two men of the 7th Dragoon Guards, on the Military Road, at their return to barracks, on Sunday evening, about the hour of 9 o'clock. The assailants commenced by knocking one of them down, and treating them with much brutality; and then met two others, whom they pursued with savage ferocity even to the New Barrack gate, and continued to throw stones, but we are happy to state without effect. The perpetrators of this disgraceful act are supposed to belong to John's-Square, as they called themselves "Garryowen Boys." The Officer commanding the Garrison has directed that a picquet of Dragoons and Infantry should patrol the neighbourhood of the New Barracks, from 9 o'clock until 10 every night, for the purpose of apprehending any of these miscreants who, under the shade of night, would raise an arm to take away the life of the protector of his country.

Wednesday night, some miscreants set fire to the premises of a respectable farmer, John Reilly, of Templenahoe, barony of St. Mullins, Carlow, when his stables, cow houses, barn, and cart-house, were entirely consumed. Reilly and his son voted for Col. Bruen and Mr. Kavanagh at the late election.

John Mortell, of Knockaney, died in the County Infirmary, on Sunday, of wounds he received from a party of men last Patrick's Day, when returning from the fair of Herbertstown. The Mayor held an inquest upon his body. Verdict wilful murder.

The numerous articles of plate, found in the possession of a suspicious character in town this day-week, are ascertained to have been stolen from Beechmount house, Rathkeale, and have been identified by Mr. Lloyd.

Government have offered £100 reward for the assailants of Constable Armstrong, and Sub-Constable Williamson, of the Police, near Crossmolina. They broke Armstrong's skull, and severely wounded Williamson.

Sixteen convicts from Naas gaol were put on board the hulk at Kingstown this week, by a Subaltern's guard of the 89th Regiment.

Andrew L'Estrange, under sentence of 7 years transportation since Westmeath Assizes, has been discharged from the hulks, as his mental faculties were impaired. He is now a temporary inmate of Mullingar gaol.

A valuable horse belonging to Mr. Mason of Lisduane, having been led out to exercise a few days back, escaped from the man holding him, and got entangled in some timber felled for sale, and before any assistance could be had he was so dreadfully lacerated that he died instantly.

A most wanton and barbarous murder was perpetrated on Sunday evening on the road between Eyrecourt and Portumna. A few minutes after 7 o'clock Sub-Constable Osborne, of the Galway Constabulary, a young man of excellent character, and but recently married, was returning to his station alone, carrying Captain Browne's fowling-piece, when he was followed, and, no doubt, taken by surprise. The barbarous assailants clove in his skull, and otherwise left
