The Mayor on Thursday held an inquest in the City Infirmary upon the body of John Dillon, who had died of wounds he received at Cahirdavin, in the North Liberties, where he was a Keeper for rent, when three or four men attacked him with stones, one of whom continued striking him on the ground with a heavy dung fork, until his leg was badly fractured, and the bone exposed, while his wife in vain threw herself on his person to protect him. The Jury returned a verdict of wilful murder against the perpetrators, who are known.

Thursday evening last an armed band of men attacked the dwelling-house of Denis Hogan of Ballybranogue, barony of Pubblebrien, in this county, and beat the proprietor in a most dreadful manner, for having entertained under his roof a keeper named O'Brien, who was placed on the adjacent lands by the proprietor. The party after giving the keeper his discharge, with a caution never to appear there again, fired seven or eight shots and dispersed.

Yesterday the body of John Hayes, a pig jobber, from Mungret-street, was found in the Poole by a fisherman. He had been missing a fortnight or three weeks. The Mayor held an inquest—Verdict found drowned.

The Commissioners of St. Michael's yesterday selected five active and intelligent men, out of no less than 79 candidates, to act as a day watch in the parish.

On the morning of Thursday last, two men belonging to the Rev. Thomas Locke, were dispatched from Newcastle to the Parish of Mahoonagh, to serve notices, for the payment of tythe composition, After serving a few on the lands of Ballyregan and Curragh, they were attacked by a number of persons on the latter townland, when one of the agents named Bevan, made his escape into the Priest's house of Castle Mahon; the other was overtaken in a potatoe-garden by two men, one armed with a spade, and the other with a thatched rake, where they compelled him to bury the notices in the earth, and said if he did not, they would make him eat them. He got some blows of the rake, and stabs of the spade were made at his face, but he providentially escaped into a house before the persons who chased his companion came up to him. Several stones were thrown after him, before he got to the house, and when some women saw him approach, they closed the door against him; but a young man, more tender-hearted, opened the door and told him he should be protected. Notwithstanding the house being surrounded by hundreds, and stones thrown at the door, the fugitive was protected from any further violence.
