. The present election makes doubt at all as to the result. Is there a Catholic in Ireland, who feels as he ought that will not strain his utmost efforts to keep this blood-thirsty faction out of power? They know that as long as the Catholic clergy are independent of the state they can never hope to retain power; they therefore seek to make them subservient to violence and corruption. They call us infidels and heathens. From this room I proclaim them tyrants, and set them at contemptuous defiance. (Cheers.) My stay on the present occasion will necessarily be but short; it will, however, be long enough to enable us to promulgate these truths. We are working out the experiment of Repeal; and that we are ready to give up altogether the moment that justice is done to us. In the agitation of the question of church-rates in Eugland I see much to rejoice at. It is for the Dissenters of England that the ministers are now struggling with a small majority. It is to relieve them from the tyranny and oppression of the establishment (and in my life I never knew a more priest ridden people than the English.) that we have ceased to press the consideration of our own claims. The meeting then adjourned till Tuesday.

SHANNON SALMON FISHERY-We have been looking on for several months past at the efforts of the present Pro-prietor of the Lax Weir to put an end to the illegal practice of fishing for some years, permitted by the Gentlemen (proprietors of estates) on the shores of the Lower Shannon by means of Scotch weirs. We congratulate him on the triumphant appeal he has made to the laws; and we trust, that having now in addition to the opinions of first-rate Counsel, which he gave to the public through the medium of our columns last autumn, obtained the sanction of both the Learned Judges on our last Circuit at Clare, Limerick, and Kerry, and through whom the Grand Juries of those Counties found true bills of indictment against the tenants and renters of the weirs: we say, that the law being now for ever established, we trust and hope it will be discontinued altogether. We give the Gentlemen (proprietors of estates on the shores of the Shannon,) a full measure of credit for having prostrated their weirs, on ascertaining from Counsel that they were illegal; and we had hoped the example would be followed by their undertenants, and farmers. We are sorry, however, to perceive that some are persevering, although, as we stated, bills of indictment have been actually found against them; and we regret this the more, as we are aware that the law will be put in force to its uttermost point, and which may entail ruin upon them and their families.
