TO THE EDITOR OF THE LIMERICK CHRONICLE.

Cork, 15th September. Sir-Having read a paragraph in your paper, Stating that a serious affray had taken place between Soldiers of the 12th and 99th Regts. at Cork, I beg to say that, you have been misinformed as to the particulars connected with it; and as I am sure that you do not wish that mistatements should appear in your valuable Journal, I beg to forward a plain and concise statement of the facts as near as they have been able to be discovered: There appears to have been what soldiers call ill will existing between some of the men of the 12th and 99th, arising out of disputes and intemperate quarrels regarding the loose women who infest the environs of the barracks at Cork, for several days previous to the Sunday evening on which the fracas occurred, and personal conflicts having taken place between individuals of the 12th and 99th, led to some of the 12th, attacking some men of the 99th whom they found in a public house on Sunday evening. Part of the picquets of the different corps, and not the 78th only, were called out; but before they could reach the spot the combatants had separated, and they only secured four men of the 99th, who were severely beaten, and one man of the 12th, who was also much injured about the head. These men are now perfeetly convalescent. I beg further to observe, that the arrangements for the march of the 99th to Fermoy, and the Depot of the 12th to Kinsale, were made before the affray took place, and not in consequence of the affray. A Detachment of three of the service compahies of the 12th Regiment are still in barracks at Cork.

But in the family and social circle his excellent qualities were still more fondly appreciated, and there the loss may be truly deemed irreparable, for in none were the relative and endearing duties of father and friend more faithfully personified. His remains will be interred to-morrow, in the family vault, at Munchin's church. Sunday last, at his house in George's-street, of a short illness

induced by cold, taken in visiting a patient at night, not far from town, James F. Carroll, Esq. M.D. a gentleman who for some years past had been at the head of his profession in this city, and enjoyed a deservedly high reputation with the faculty and the public.
