There is no probable cause assigned for the above shocking outrage, which was perpetrated in the neighbourhood of military and police stations, and at the close of the maiden assizes for Tipperary, -over 70 persons having been returned for murder, and not one convicted! What will Judge Moore say to this homicide in his next charge, if he goes that circuit? Reckless indeed must the desperadoes in that county be of human life, after so clear an acquittance at last assizes. There is, however, in the eyes of a christian and moral world, a deep stain upon the character of the county of Tipperary, which not all the rhetorical artifice of judicial oratory can efface, whether administered from the Bar or the Bench, to mitigate the appalling enormities of habitual bloodshed and crime in that devoted quarter.

HORRIBLE OUTRAGE. -On the night of Wednesday; the 28th ult. while James M'Carthy, of Lackamore, a bailiff on Lord Stradbroke's estate, at Bilboa, lay in bed with his family, the crackling of flames, with almost suffocating heat and smoke, aroused him from sleep, when the poor man was astounded to find his cabin in flames, and the roof threatening every instant to fall upon his wife and children. He pulled them, almost stupified with terror, outside the burning premises, and bethinking himself of a bex containing papers or deeds of some interest to his Lordship's property, M'Carthy risked his life by rushing back into the flames, and securing the box, was lucky enough to escape with his prize into the open air, shortly after which the roof fell in, and all the poor man's furniture was destroyed by the conflagration. His loss, however, did not terminate here, as the adjoining barn was also found to be in flames, and ten cows, the profits of his industry, and the provision for his family, became a prey to the midnight incendiary, and were absolutely burnt alive !-What affords evidence to prove that this horrible outrage was the act of malicious incendiaries, is the fact that M'Carthy the day before had to serve on tenants who were four years rent in default, a decree of ejectment, under authority of Lord Stradbroke's agent, Mr. Coates. M'Carthy, from a state of comparative comfort, is thus reduced with his wife and children to mere penury; and some of his more considerate neighbours, tenants on the property, have not only come forward to vindicate the character of Mr. Coates from unjust aspersion, but to offer a reward for the authors of the above outrage. Lord Mulgrave has promptly offered 1001. to discover the barbarous perpetrators. A man of the name of Daniel Griffin was waylaid
