"The Committees are progressing with manifest injustice to the Conservative side. In the Wicklow case, yesterday, an attempt was made to open the registry, and the arguments were so conclusive that even the Radical member for Southwark. Mr. D. W. Harvey, voted for it, but the other side was too strong in numbers, and the attempt was defeated, so that no other alternative being left after a factious decision, the petitioner, Colonel Acton, withdrew from the contest, leaving the sitting members in possession of both seats, one of which they defrauded him of at the hustings, and secured at the ballot, when they persevered in seeking a double strike—a proceeding for which no precedent can be cited, and the enforcement an outrage on our common understanding. In the Hull, in like manner, the Committee composed of a majority of Whig-Radicals, as I have already stated, are most sedulous in deciding almost every case, however absurd or monstrous, against the sitting members, from the fact of their being Conservatives. Voters are struck off the poll for having taken a simple glass of ale on the day of election, for which they did not happen to pay, and all this outrageous conduct is sought to be covered by the Treating Act. Not satisfied with that, the votes of gentlemen of the first respectability have been erased from the poll, on the unsupported testimony of witnesses, who, on their own showing, would be scouted from a Court of Law. Among the instances of injustice, one occurred yesterday which will speak volumes for the bias of the Whig members of the Hull committee. After a witness had acted his part, so as to have ten votes struck off on his testimony, his own vote was then impeached. In the course of cross-examination he was asked whether, if he had not received the refreshments, he would not have voted for the "blues," (Conservatives,) as he had invariably done before. His reply was that he would have done so—that what he had then taken did not, in the least, influence his vote. Notwithstanding that the Committee, to be consistent with their previous decisions struck off the vote, thus a corrupt motive though he had sworn to the contrary After this decision you may perceive that I can hold out no expectation of success for our friends for Hull, who cannot by possibility go into their case, and then it is supposed after an expenditure of nearly twenty thousand pounds between the contest and the scrutiny. Here then is an evil at which neither murmur nor reproach is heard from a single Conservative-but the instant a decision is pronounced against their opponents, they cry out and rail, and when redress is looked for our impartial Ministry throws its shield over the offending and offensive party.

"In the Kinsale Committee the same game is sought to be played in favour of Mr. Pierce Mahony, but these (the Whig-radicals) have not it all their own way. The Committee has been detained for the last few days in frivolous objections, to enable Mr. Mahony to remain a franking member during the recess. His objection against the freemen was over-ruled this evening, which decided his fate—but he will persevere until the rising of the House on to-morrow, and perhaps may make a show of resistance until the day after, and then it must be all up with him. Thomas, 20th, retains his majority of one undisturbed. "Although it is announced that the strength of

DELAPIDATION AT RATHMORE.

John Blennerhassett and Thomas O'Grady, Esqrs. were the presiding Magistrates at Ballyneety Petty Sessions on Thursday, when a further investigation of the outrage at Rathmore was instituted, and John Birrane, was identified by the Police as one of the personstearing up trees at the residence of the late Rev. Mr. M'Carthy, P.P. of Fedamore, which became such a wreck and ruin when his successor, the Rev. Mr. O'Regan, intruded on the premises, and soon after deserted the place. Archdeacon Maunsell did not press a conviction under the 9th George 4th, and Birrane declared he was led a stray by the bad example of others in that scene of plunder and destruction. Thomas Shea was next charged with having a quantity of young trees, cut and broken, in his possession, from the above farm.

Archdeacon Maunsell said-From the commencement of this unpleasant business, Gentlemen, to the present, I have undertaken those prosecutions with peculiar reluctance, principally because the parties prosecuted were not the principals but the instruments made use of to perpetrate an outrage unparalleled in this country. It is my firm belief, that, had a good example been shewn the people, the farm upon which this outrage has been perpetrated, would be in the very same state now that it was three months since. For that reason, I am disposed to deal as lightly as possible with those poor people. If it be not necessary that the penalty should be enforced, I am quite satisfied to have it remitted altogether-myanxious wish being that the bench should deal towards them with the utmost lenity And, although timber, to a great extent, has been found in the prisoner's house, yet, taking into consideration the influence under which he acted. I shall feel obliged to the bench if, even towards him, they act with lenity. In making this request and in bringing those cases to a close for the present, I have only to say, that the day is not far distant when the guilty parties in this transaction, who have directed the poor plunder and delapidation, will be exhibited, in their proper light, at the bar of justice, when the public will see that they well merit the sentence that awaits them.
