seventy or eighty winters have planted on your brow, and the spiritual dignity with which you are invested, alike discourage me from inflicting due chastisement upon you. In truth, Mr. Bruce, this dilemma puzzles me, and the only way in which I can get out of it is this :- I will suppose you, for a moment, to be a young man, and no clergyman at all. I will strip you of your age and gown, and divest you of such external appearances as denote your apostolic character. Instead of a preacher of peace and a proclaimer of truth, you shall be a plain country gentleman like myself. And Lishall suppose myself to be the Reverend Parson Bruce. I shall borrow my costume as a clergyman from your sombre wardrobe, and shall clothe myself in all the other outward semblances of your godliness and charity. I shall assume your clerical deportment, your solemn air, and calm couptenance so expressive of a mind reposing in its own virtue. Now, Sir, following up this very violent apposition, imagine me to be in the administration of the functions of the priesthood, and pair (a fou are,) for the performance of good works of the patrimony of the Church. Imagine me to be a minister of your own district, and your spiritual friend-a teacher of truth, and inculcator of universal charity. Tell me, Sir, what opinion would you form of me as a clergyman, if I were to insult and defame you? What would you think of me, if I were to spread evil report against my neighbour, and say of him "the thing that is not"? What would you think of me as a professor of divinity, were I to publish slander against another, or were I to abuse my influence with my flock and instead of enforcing precepts of benevolence among them, were to incite them to ill-will by my own example? If I were to give currency to an untruth, knowing it to be so, inasmuch as it was fabricated by myself, and were to tell you, Sir, that you "were held in contempt by every gentleman in the country," at the same time that every gentleman in the country falsified the calumny; should I not outrage all your pre-conceived notions of me as a Christian minister? For my part, not think that these things, fraught with such social wrong, would be in consistence with my patriarchal age or reverend office; I do not think they would reflect credit upon me as a man, or a man of honor. Personating Mr. Bruce, I should shrink from scandalising my order and involving my own fame by this species of detraction-I should fear to damage my patrician name made sweet by so many family odours. As Mr. Bruce, I should teke care not to sully a renown that is scented like the violet, and that must ever retain its freshness while the " Nosegay" blooms. I should pause ere I harmed a reputation that has been estimated (if a kindred case be the standard of value) at a very high price in the Courts of Law. Believe me, Sir, there are hard words in the vocabulary that admirably apply to the name but I shall not connect them with so honored a patronymic.

Contempt, Sir, is not a missile that should be hurled from any hand for the gratification of private rancour. Warmed by an indignation which even the sight of an old man and a priest could not repress, you might reasonably ask me (for remember, I continue to personate the Rev. Mr. Bruce) how I dared to throw discredit on your character by my wholesale imputation? Might you not suspect that I calculated for impunity upon my venerable form and the respect that is accorded to my profession? You might ask me who gave me authority to denounce you in so sweeping a manner on the part of a whole community? You might enquire by what process of inflation my lungs had been swelled into an amplitude that enabled me to declare the voice of "every gentleman in the country?" Would you not arraign my arrogance, and tell me that it was the usage of refined society to express congregate opinions or sentiment through such a source alone as should sustain their dignity, and give

Having asked you these few questions, I shall restore you your suit of sables, and assume my own name again. You are an arbiter elegantiarum, and have been pleased to pronounce my productions to be "unworthy of comment or observation on account of their vulgarity." I confess, Sir, that this wounds my literary vanity; but, after all, it is a matter of taste, and I cannot quarrel with your peculiar notions of composition, any more than with your doctrine of ethics.
