Our columns are so crowded with a report of the speeches at the Dinner, on Thursday night, to Mr. O'Connell, that we can only conclude by briefly stating his departure, yesterday, for Ennis, where he dined with his relative, Mr. Charles O'Connell, Attorney, and this morning proceeded to Kilcornan, Co. Galway, the seat of S. H. Redington, Esq. M. P., for Dundalk. To-morrow, he enters Galway, and remains with Dr. Browne, the Roman Catholic Bishop, until Monday, when he dines in public with his friends, and then finishes his tour of provincial feasting and agitating, by a detour upon Dublin.

One of the most respectable and numerous meetings assembled in Cork for many years, took place on Thursday, to establish a Provincial College for Munster in that city, Lord Listowel presided, and Mr. Wyse, M.P. made a splendid speech in illustration of the grand national object for which the meeting was convened. Eventually an address to the Queen, and a petition to Parliament were agreed on.

John Carroll, Esq. late of the National Bank, Brunswick-street, was, on Thursday, elected by the Commissioners. Collector of Wellesley Bridge dues, iu place of James Lyons, Esq. resigned. The appointment has given general satisfaction, for a more eligible selection could not be made.
